### in consideration of S.B. 1123 RELATING TO SPORTS.

Chair Fukunaga, Vice-Chair Wakai and Committee members:

The Department offers the following comments regarding Senate Bill 1123, which creates the office of sports development within DBEDT.

The Department recognizes that national and international sporting events are a natural fit for Hawaii, and that the state derives tremendous benefits from the visitors who come to attend the events and the media coverage generated. The Department believes, however, that the state's sports marketing and development plans should be part of the overall tourism marketing and development strategy for Hawaii, which is the responsibility of the Hawaii Tourism Authority (HTA). The HTA, by statute, is responsible for the marketing and promotion of sports-related activities and events. Establishing an office of sports development within DBEDT would be duplicative of HTA's efforts. Therefore, the Department believes that this measure is unnecessary.

The Hawai'i Tourism Authority (HTA) opposes S.B. 1123, which proposes the establishment of an office of sports development in the Department of Business, Economic Development and Tourism to, promote and market the sports industry in Hawaii, develop a longrange plan for sporting events and sports activities, promote Hawaii as a place to hold sporting events.

As part of its responsibilities to market and promote sports-related activities and events, the HTA has on staff a Sports Manager. The Sports Manager, worked with the HTA's Sports Investigative Committee, to develop a plan for the promotion of sporting events and new sporting products that could be integrated into an overall sports marketing and promotion program for the state. HTA's 2010 Sports Marketing Program included:

- Bringing stakeholders to make Hawaii's winning bid for the 2012 World Vintage Rugby Carnival, a seven-day event attracting more than 60 teams from 10 countries;
- Four PGA professional golf tournaments;
- The Sheraton Hawaii Bowl;
- The Diamond Head Classic basketball tournament;
- The Ford Ironman World championship;
- Xterra World Championships;
- EA Sports Maui Invitational; and
- Xterra Trail Run World Championship.

In addition, HTA supported sporting events such as the Na Wahine O Ke Kai, Molokai Hoe, The Stand Up World Tour Finals, the Quiksilver in Memory of Eddie Aikau, and the Waikiki Roughwater Swim.

The HTA's Sports Program is one of the major components of the Authority's overall State Marketing Program which is designed to market Hawai'i as an overall visitor destination. Having the sports program under the HTA's purview allows for its integration into the Authority's overall global tourism marketing efforts. As such, establishing a separate entity for sports marketing and promotion would take away from the tourism marketing synergy and continuity that HTA presently has.

The HTA is already addressing sports marketing, promotion, and product development to enhance Hawaii branding as a sporting events and activity destination. Therefore, S.B. 1123, is not necessary and we request that it be held.

I write to you in support of **Senate Bill 1123** for the establishment of an Office of Sports Development within the Department of Business, Economic Development and Tourism.

Many cities and states around the country have dedicated staff members to actively seek and pursue opportunities to host large sporting events. On behalf of the Hawaii Youth Soccer Association, I have helped organize the 2003 and 2008 US Youth Soccer Region IV Championships. Each of these events had an estimated economic impact of over \$10 million. We have also unsuccessfully bid for the US Youth Soccer National Championships and the US Youth Soccer Coaches Workshop & Convention. In each case, our bid proposal as well as our presentation were put together and presented by our volunteers, while their City, County or State Government supported the cities we were competing against.

Hawaii Youth Soccer Association is again bidding, later this month, for the 2013 Region IV Championships, and again we are competing against Cities that have the direct backing of their State Government.

We all know how vital tourism is to our State's economy. Sports Tourism is a market segment that we have not fully penetrated. The establishment of an Office of Sports Development tasked with pursuing Regional, National and International sporting events should be a priority in the marketing of our State as a world class host for sporting events.

I believe a dedicated office of sports development at the Department of Business, Economic Development and Tourism can benefit youth baseball exchanges. In closing, when establishing this sports office, please keep in mind the potential of school age sport tournaments in Hawaii. You would be surprised how valuable these events are to Hawaii's economy.
