I am Mihoko Ito, submitting comments on behalf of the Consumer Data Industry Association (CDIA). Founded in 1906, CDIA is the international trade association that represents more than 400 data companies. CDIA members represent the nation's leading institutions in credit reporting, mortgage reporting, fraud prevention, risk management, employment reporting, tenant screening and collection services.

CDIA **supports the intent** of S.B.1162, SD1, which requires government agencies to develop mandatory training programs for government agencies who have access to personal information; requires security breach reporting to the information privacy and security council and appropriates funds for this purpose.

Federal and state laws require the private sector to maintain safe and secure databases and data transfers. State laws also require the private sector file freezing and security breach notification. This measure puts the government one step closer to the standards to which the private sector must already adhere.
