### RELATING TO PERMITTING

Chair McKelvey and members of the Committee, thank you for the opportunity to testify on S.B. 1213, S.D. 1

The Department of Accounting and General Services (DAGS) opposes S.B. 1213, S.D. 1 for the following reasons:

- DAGS does not have the available resources needed to achieve this Legislative request.
- 2. DAGS does not have any administrative or jurisdictional control over the Counties when it comes to streamlining their Building Permit approval process and County Council adoption of administrative rules, codes, etc. Therefore, this Legislative initiative should remain with the respective Counties to address.

3. In lieu of this bill, it is suggested that the Legislature consider proposing a resolution that asks the four Counties to form a joint committee that will work on submitting a report to the Legislature on how the Building Permit approval process can be improved, whereby the Chair of the joint committee would be elected from the members of that group.

I think it would be beneficial to have a task force to expedite the process. I am very interested in Urban Housing and Development. I was told about ACT 201H by the DPP Director that would apply and could possibly benefit from. However, not knowing where to being is the problem. Perhaps if the City and County had a special task force that would help guide me, almost like a concierge, it would be very beneficial in getting such projects or similar projects done.

I have observed that the process to get a house built on Oahu compared to that on the Big Island has been almost tripled the time. The permitting process here on Oahu was very tedious, and many people were involved in the process making it even more complicated. It's almost like having "too many cooks in the pot".

On several occasions, I was told I needed to hire an attorney. If I hired an attorney every time someone told me I needed an attorney, I would be broke, and would never have had a chance to break ground with any of my projects. If the City and County Department had some simple legal forms or examples for us "newbees" to follow, then we can do our own paper work.

I once knew someone who wanted to rezone a portion of his land. He hired an attorney, did a lot of paper work, and spent a lot of money. In the end, he never got it rezoned, and his attorney wanted more money. A lot of work was already done, but unfortunately he gave up and walked away thousands of dollars broke!! And soon after, he passed away.

Thus by having a task force that would help to fill out paper work, draw maps, then perhaps people would be looking to bring more projects to the table.

If this State and the City wants to move forward with construction projects, then we need to have a concierge or task team to help inspiring developers get the necessary things done. This is where the Obama administration could help

business leader's move forward by helping to get the paperwork done. This is where people get "stuck", and end up sitting on projects.
