1 **Department's Position:** The department respectfully opposes this measure.

2 Fiscal Implications: As yet, un-quantified resources would be needed to adopt and enforce rules.

3 **Purpose and Justification:** The bill proposes to amend Chapter 342F, Hawaii Revised Statutes, to

4 limit the duration of leaf blower activities.

5 We appreciate that some people dislike noisy leaf blowers. Noise can be a nuisance and disturb

6 sleep, even if it does not reach the levels that cause hearing damage. However, the intent of Chapter

7 342F, Hawaii Revised statutes was to regulate stationary equipment, construction, agricultural and

8 industrial activities. These types of sources are either fairly constant in nature, stationary or restricted to

9 a certain location, and can be enforced more easily. Enforcement against leaf blowers would be

10 extremely difficult due to their mobility and duration of use.

# In consideration of SENATE BILL 132 RELATING TO LEAF BLOWERS

Senate Bill 132 limits the use of leaf blowers to an unspecified number of minutes per day per parcel. The measure further defines a parcel to be contiguous parcels owned by the same individual or entity. The Department of Land and Natural Resources (Department) does not support this measure as it would adversely impact our ability to maintain public grounds and facilities. The Department uses leaf blowers to assist with the maintenance and appearance of parks. Use of these labor-saving tools is increasingly important, especially with the loss of funding and park maintenance positions.

It would be unfeasible to work within the "per parcel" limitation as defined in this measure. For example, Kokee State Park, Waimea Canyon State Park, Haena State Park, and the Na Pali Coast State Wilderness Park would be considered one parcel.

#### Subject: Senate Bill 132 – Relating to Leaf Blowers

The Department of Parks and Recreation (DPR), City and County of Honolulu, opposes Senate Bill 132. This bill will prevent DPR from performing its duty in an efficient and cost effective manner. In the current economic climate, operational efficiency is critical.

The restriction on the use of leaf blowers will be costly, time consuming and a less effective use of our labor and limited resources. Sweeping is currently limited to small work areas and projects. It is not practical to sweep a large area such as a park and its parking lots.

In the course of the last ten years, the gas leaf blowers have made vast improvements in the reduction of noise pollution. Current machines on the market are available with operating levels as low as 65dB.

Our staff is trained in the use of all equipment they operate. Equipment manufacturers also provide manuals as to the proper use of their equipment. Our staff makes every effort to insure that the equipment being operated is being used in the correct fashion it was designed for.

# On SCR15/SR5 Relating to Leaf Blowers

Chair Gabbard, Vice Chair English and Members of the Committee:

The Downtown Neighborhood Board strongly supports SB 132 which places additional time restrictions on the non-governmental use of leaf blowers. year was.

Our Downtown/Chinatown neighborhood is very densely populated. We do understand that it is necessary to keep the area clean of debris, leaves and other trash that gathers so often in such neighborhoods. But there may be alternatives to the use of leaf blowers that are far quieter, relatively inexpensive and actually less hazardous to operators and passersby.

We do not have a specific recommendation as to the length of time, per day, that leaf blowers should be operated. Certainly that metric is a combination of the type of terrain, the amount of debris, such as after a windstorm, and other parcel specific factors. We will leave it to the operators of this equipment to offer suggestions on this provision of the bill.

Landscape Industry Council of Hawai'i (LICH) supports Senate Bill 132 with amendments

LICH acknowledges the public's concerns regarding the use of gasoline-powered leaf blowers generating noise, dust, and air emissions. Most professionals use leaf blowers responsibly, however a few culprits use old technology or improperly use their equipment. This is mainly a lack of knowledge that can be remedied by means other than indiscriminate bans.

Just ten years ago, leaf blowers averaged about 78 decibels, equivalent to a motorcycle. Most leaf blowers now produce less than 65 decibels. For every six decibels reduction, sound intensity is actually reduced by 50 percent. That means many of today's leaf blowers are four times quieter than ten years ago. Leaf blower manufacturers will continue to make improvements making them even quieter.

While leaf blowers occasionally stir up dust, so does sweeping with a broom. We often see the alternative to sweeping or leaf blowing which is using our precious drinking water in substantial amounts to wash away cuttings and debris into our storm drains ultimately ending up on ocean reefs. Leaf blowers are clearly more sustainable.

Most green industry experts agree that it takes at least five times as long to clean a landscape site with a broom and rake as it does with a leaf blower. It is estimated that landscape costs and therefore charges to the consumer would increase from 20 to 40 percent if operators must perform the same functions without a leaf blower. LICH believes many clients will not be able to afford or will not pay for the additional costs of performing lawn and landscape maintenance without leaf blowers and resort to less than desirable methods like drinking water. Leaf blowers are clearly an extremely valuable tool, saving an enormous amount of time and money.

Establishing a maximum allowed leaf blower time by property is difficult due the variety of sizes of residential and commercial properties on the different islands. LICH recommends any time limit be restricted to residential properties and consider the variety of residential properties on the different islands.

LICH believes that many alternatives currently exist that would alleviate the public's concern about leaf blowers without depriving the green industry of this extremely efficient, sustainable and safe tool. We wish to help find a solution to this issue that is fair and equitable to both the public and contractors who use leaf blowers. LICH would like to propose practical and comprehensive measures to address these concerns once and for all.

The Landscape Industry Council of Hawai'i supports the leaf blower best management practices for commercial operators based on national industry standards from Professional Land Care Network (PLANET):

# Landscape Industry Council of Hawai'i Leaf Blower Best Management Practices

- Leaf blowers should not be used in residential areas at unreasonable hours.
- Leaf blowers shall not be modified.
- Debris shall never be blown onto adjacent property, the street, vehicles, people, or pets.

- Where space allows, leaf blowers should not be used within 10 feet of doors or windows.
- Rakes or brooms should be used to loosen heavier debris.
- The full nozzle extension should be used according to manufacturer's recommendations.
- The muffler, air intakes, and air filters shall be routinely checked to make sure they are working properly.
- Leaf blowers should not be used to move large debris piles from one spot to another.
- All commercial operators shall employ one LICH Leaf Blower Best Management Practices certified professional.

We propose the following amendments:

Adding after "provided that"

(I) All commercial operators after 1/1/2013 shall employ one LICH Leaf

Blower Best Management Practices certified professional.

LICH believes these are practical and comprehensive measures that will address the public's concerns while manufacturers continue to make leaf blowers even quieter. We are ready to work with the legislature for meaningful change. If you would like to discuss this further, feel free to contact me.

# Re: In Opposition of SB132

While Performance Landscapes is in favor of restrictions to control blowers, we would oppose further legislation for the following reasons:

- The limitations on blowers may increase costs to some of our clients dramatically.
- Some clients will ask us not to remove debris and will cause it to blow naturally off property, causing pollution.
- Some clients will turn to "cash" yardmen who will not comply with the law.
- Professional landscapers are trained to use blowers; within certain hours, safely, minimizing debris and noise, based on site and weather conditions.
- There are lower decibel blowers on the market with mufflers that mitigate issues.
- The Dept. of Health already has noise rules regulating noise of "industrial, construction, and ag. Equipment". Landscape Equipment should/can be added to existing law rather than creating a new one.
- Mowers, weed-whackers, hedge-trimmers, chainsaws, and many other power tools are not covered by this ban.
- It should be the consumer's choice to weigh the benefits of paying more for service, not the state's.

I personally would not like to hear blowers, or any other loud noises waking me up early Sunday mornings. I am willing to work on legislation with any interested party that will modify this bill without the <u>adverse economic and environmental</u> effects I believe a further legislation may cause.

I am Bishop, the owner of Bishop's landscaping maintenance. I Have used gas powered leaf blowers in my business for years.

I am testifying in support for SB 132, knowing full well that it is a hard decision, due to the direct implications of it affecting my work. I have gotten complaints over the years about the noise, and pollution the use of the leaf blowers cause. The noise leaf blowers make are very inconvenient for all who use them, or those who are force to hear them, I know that any thing over 90 to 95 decibels may result in hearing loss 90-95db, and anything after that as low as 82 decibels will cause damage to the ear. I measured the sound of these with a decibel meter reader and from 15 feet away the blower is at 92 decibels. So not only is the leaf blower causing harm to the operator, it is also harming those who hear the loud noise of the leaf blower. I believe that to curtailing the use of leaf blowers to 15 min. is a great step in the right direction.

My name Is Ruben Perez 1 am in support of Bill SB132. Leaf blowers cause unnecessary noise that interfere with our quality of life. I am a father of two toddlers who nap during the day. I do security work during the night so I sleep during the day. We have neighbors on all sides of our house who pay landscapers to do their yards. The leaf blowers they use are constantly waking us up and interfering with our daily life. Many times we have to revolve our family events around our neighbors landscapers. The idea that leaf blowers save time - which is the one and only argument for using them is outrageous, since it implies that the time stolen from the rest of us is worthless. Gasoline leaf blowers have been banned in many of California's counties, including Los Angeles and hundreds of county's across the U.S. and Canada, and none of the horrors that were predicted by landscapers - untidy lawns, escalating costs, declining property values - has ever come to pass. The World Health .Organization, 1980, Environmental Health Criteria 12: Noise, recommends an outdoor level of 55 decibels and a level of 45 decibels to meet sleep criteria.
