MEASURE: S.B. No. 1343

TITLE: Relating to Electricity Rates.

Chair Nishihara and Members of the Committee:

DESCRIPTION:

This bill amends chapter 269, Hawaii Revised Statutes ("HRS"), by including a new section to authorize the Public Utilities Commission ("Commission") to establish preferential rates for electricity used for agricultural activities in a public utility's service area.

POSITION:

The Commission appreciates the intent of this bill to assist and encourage agricultural activities, but has concerns because of the effect it would have on increasing electricity rates for the majority of ratepayers unnecessarily and, therefore, defers to the Legislature's policy determination regarding mandating preferential electricity rates for agricultural activities.

COMMENTS:

As the Legislature considers whether to require preferential rates for electricity specifically for agricultural activities, the Commission respectfully notes that this practice may be contrary to the Commission's regulation of rates and ratemaking procedures under HRS § 269-16, which prohibits "unreasonable discrimination between localities or between users or consumers under substantially similar conditions."

In effect, as provided for in this bill, any preferential rates for electricity used for agricultural activities would more than likely be subsidized by the electricity rates charged to other ratepayers of the public utility.

The Commission expresses serious reservations about this bill's effect of increasing the ratepayers' already heavy economic burden during the current difficult economic environment.
