Subject: SB:1364 Establishes a domestic violence task force to make recommendations to address domestic violence in Hawaii and then report to the legislature.

I am writing in opposition to this bill. This bill is a duplication of existing efforts. I am a consultant in private practice and for the last three years have been hired to facilitate the work of the State Domestic Violence Prevention Plan Oversight Body Implementation Team and track implementation of the Plan Performance Measures. The Plan was requested by the Legislature in 2005 and adopted by the Department of Health to oversee its implementation in 2007.

At that time a public/private policy level Oversight Body was established to review the progress of implementation and update the plan as necessary. There are currently 13 members, that body is attached to this testimony. The Oversight Body meets minimally quarterly and more frequently as needed. This is a hard working, committed group of individuals who see the success of the plan as their responsibility; they are active on subcommittees and consider themselves barrier busters and system improvers. They have developed an annual work plan that is tied to the outcome indicators of the State Plan.

The Oversight Body's efforts are matched at the community level by Domestic Violence Community Task Forces; one on Kauai, Oahu, Hawaii Island, Lanai, Molokai and two on Maui. Their work is guided by the Plan Performance measures.

If there are recommendations for improvement I would ask that those suggestions be made using the infrastructure currently in place, not create a parallel system.


Aloha,

Chair Chun Oakland, Vice Chair Ihara, and members of the Senate Committee on Human Services, the Hawai'i State Coalition Against Domestic Violence (HSCADV, the Coalition) respectfully submits the following testimony opposing SB1364. As a statewide coalition of domestic violence service providers, our mission is to ensure the safety and protection of women in intimate relationships by providing training and education, coordinating domestic violence prevention and intervention services, affecting public policy, and establishing coordinated and consistent procedures and actions by the civil and criminal justice systems in Hawaii.

While we are supportive of initiatives to address domestic violence, SB1364 is duplicative of existing efforts. SB1364 calls for a domestic violence task force to make recommendations to address domestic violence in Hawaii and then report to the legislature. In 2007, the Domestic Violence Strategic Plan for the State of Hawaii was developed as directed by the 2005 State Legislature in SB1419, SD1. Each of the island task forces and the Oversight Body for the Strategic Plan were established with the goal of creating a system of support that is community-based, coordinated, culturally appropriate, and accessible to all families.

We are now in year three of implementation of this plan, and have had the consistent participation and commitment of survivors, department heads, legislators, city councilmembers, and community and organizational leaders in the current infrastructure.

Instead of initiating a new task force, we ask for the necessary investment and support to fully implement the strategic plan and address the following needs:

- Increase community awareness and education about domestic violence
- Ensure that victims are safe and receive support services and
- Assure that batterers are accountable for their behavior and learn skills to become non-violent.

We welcome the participation of legislators and high-level cabinet officials who will join us in this effort.
