<u>PURPOSE</u>: The purpose of this bill is to Reduces the number of members of the State Rehabilitation Council from twenty-one to fifteen.

**DEPARTMENT'S POSITION:** The Department of Human Services (DHS) supports this bill.

The State Rehabilitation Council (SRC) is a mandated council under the federal Rehabilitation Act. Federal statute prescribes the composition of the council to include membership of individuals with disabilities, representatives from consumer organizations of people with disabilities, service providers and business and industry. The federal minimum number of required positions on the SRC is fifteen.

The SRC has historically had difficulty in reaching quorum with the current

State required minimum of twenty-one and it is the belief of the SRC that there would

be a greater chance of achieving quorum with the more manageable federal

minimum of 15 members. This change will ensure that the SRC is able to conduct business in a timely manner.

SUBJECT: S.B. 1417 – RELATING TO THE STATE REHABILITATION COUNCIL

Dear Chair Chun Oakland and members:

My name is Jonathan J. Chun and I am the Chair of the State Rehabilitation Council (SRC). The SRC is a mandated council under the Federal Rehabilitation Act. Federal statute prescribes the composition of the council to include individuals with disabilities, representatives from consumer organizations, people with disabilities, service providers and business and industry representatives. Federal law sets a minimum of 15 persons to sit on the SRC. The SRC is required by federal law to meet a minimum of 4 times a year. Last year the SRC was only able to convene one meeting due to a lack of quorum. The members of the SRC are all individuals committed to assisting those with physical and cognitive disabilities. All the members, however, are volunteers and leaders in their own communities. Coordinating everyone's schedule is not an easy task. It is the belief of the SRC that there would be a greater chance of achieving quorum with the more manageable federal minimum of 15 members. This change can be made without sacrificing the required membership criteria set forth in HRS Section 348-8. Thank you for this opportunity to testify.
