Dear Chair Hee, Vice Chair Shimabukuro and Members of the Committee on Judiciary and Labor:

Hawaiian Humane Society supports the passage of SB 1424, which would make it illegal to tie up a dog under certain conditions with exceptions. We believe that the chain should never weigh more than 10 percent of the dog's weight and be at least 6 feet in length. Even these circumstances are not ideal but they do set minimum requirements for their welfare.

In 2009, the Society led a task force composed of a broad sector of pet-related organizations that included, island humane societies, veterinarians and law enforcement to develop guidelines for a successful bill that would benefit the welfare of dogs, as well as be enforceable.

It is a proven fact that dogs chained for life suffer psychologically and pose a public safety issue. In 1996 the US Department of Agriculture "concluded that continuous confinement of dogs by a tether is inhumane". Dogs that are most likely to bite are unneutered males that are chained for life.

We ask for your unwavering support of SB 1424.

SB 1424 RELATING TO OFFENSES AGAINST PUBLIC ORDER.

Creates an offense of confinement of a dog by tethering under prescribed circumstances with certain exceptions and establishes mandatory fines. Effective 1/1/12.

Chairman Hee, Vice Chair Shimabukuro and Members of the Committee:

My name is Alan Gottlieb, and I am a rancher and the Government Affairs Chair for the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council supports SB 1424 with one suggested change in language.

Last year we had strong concerns about a similar bill, as it did not take into account the tethering of young dogs during training for livestock handling. The bill this year does take this into account. The only change we suggest is on Page 2, line 8, adding the words "or Livestock" to the end of the sentence, so it will read:

"...and provided further that a person is not prohibited from using these restraints or from restraining a dog under the age of six months while the dog is engaged in an activity, including training, that is directly related to shepherding or herding livestock, or when reasonably necessary for the safety of the dog <u>or livestock</u>."

I know that you have likely received several messages focusing on the same points about chaining of dogs. So I will add just a personal anecdote to the mix.

I have a medium-sized mixed breed dog. I walk her around my neighborhood three times a day, and we know most of the other dogs around. There was a house nearby that recently acquired two lovely puppies, which looked like lab mixes. The pups were kept chained to a tree in the yard, near a staircase.

Once when I walked by, the dogs had completely wrapped each other up in the chain, to the point where one of the dogs could not put his rear leg down, and it was clear that the circulation was being cut off. He was in danger of being seriously injured. I tried to get the attention of someone in the house, but wasn't able to. I finally went into the yard, unchained the dogs, untwisted the chain, and then (it broke my heart to do this) chained them back up. Another day, a friend walked by and saw one of the dogs dangling over the side of the staircase being choked by the chain. She, too, had to enter the yard to save the dog from serious injury or death.

When these dogs first arrived, they were happy and playful. They would run to the fence and greet passersby. I would often stop to pet them, but would stop when I noticed they were covered in their own feces (unable to do what dogs prefer... eliminate far from where they sleep and eat). They wagged their tails and bounded about to the best of their abilities. But it was clear that the more they bounded about, the more pain they were caused by the chain. So these happy, playful dogs turned into sad and sullen creatures within a matter of just weeks. They no longer greeted me when I walked by, nor showed any interest in each other. Eventually, one of the dogs ran away (given a split second off the chain, he never turned back), and I now no longer see the other dog in the yard either.

It is clear that owners who treat their dogs in this manner are not responsible. It is detrimental to the dogs (and to the neighborhood, as not all dogs become sullen when chained... many become overly aggressive, endangering local children and other animals). In addition, chaining dogs provides absolutely *no benefit* to the human owners, so there is no reason in the world to preserve the "right" of owners to treat their dogs in this inhumane manner. I hope you will vote for the obvious correct choice, supporting Senate Bill 1424 and preventing such a clear-cut case of animal cruelty.

I am currently a Certified Professional Dog Trainer, and have spent the last 22 years of my life working with dogs. I spent 16 of those years in animal welfare. I spent 8 years as a Humane Investigator and 5 years as an Animal Control Officer. The other years I did humane education and animal behavior. I have met thousands of dogs in my career that have suffered the ill effects of being chained. Many have injured themselves, sometimes hanging themselves which led to their death.
