Subject: Senate Bill No. 1458, S.D. 2, H.D. 1, Relating to Health

I am Jerry Inouye, Captain of the Narcotics/Vice Division of the Honolulu Police Department.

The Honolulu Police Department opposes Senate Bill No. 1458, S.D. 2, H.D. 1, Relating to Health.

We oppose this bill because marijuana is not considered modern medicine. The smoked form of marijuana is not considered modern medicine because the potency and dosage cannot be controlled. In addition, the quality of the marijuana cannot be guaranteed. There are synthetic forms of tetrahydrocannabinol (THC, the psychoactive ingredient in marijuana) already legally available by prescription (i.e., marinol).

This bill seeks to have the state regulate the distribution of marijuana similar to pharmacies in our community that dispense medicine. Marijuana has a high potential for abuse and can result in addiction. According to the Alcohol and Drug Abuse Division of the State of Hawaii Department of Health, 31.3 percent of those admitted for treatment (adults and juveniles) in 2009 stated that marijuana was their primary substance of abuse.

Reducing the availability and keeping drugs illegal will lessen the willingness to use them. Regulating these drugs widens the availability and misuse regardless of the controls that are in place.

Opposition in Current Form Aloha,

It is with a truly heavy heart that we must submit this testimony in opposition to SB1458 SD2 HD1. SB1458 was a great bill in its original form and was made better in SD1 and SD2. The Senate version would have increased access to safe medicine for thousands of Hawaii medical marijuana patients while putting into place a regulated, taxed, and safe system of dispensaries. Unfortunately, House Draft 1 of SB1458 stripped all of this out of the bill and instead inserted a 5 year trial run on Maui.

A trial period is not a bad idea on its own but the timing is simply too late. The time for a trial period was 11 years ago when Hawaii led the nation by becoming the first state to legalize the medical use of marijuana. We could have tested the waters with a trial run on dispensaries then but we chose not to. Fast forward 11 years and the need for a trial period no longer exists. Dispensaries have operated in California, granted they are unregulated, for years with little to no harm to their communities. Colorado has had dispensaries for 2 years in a completely regulated environment with much success. Arizona's fully regulated program begins in April. New Mexico's program allows regulated dispensaries. Rhode Island and Maine will be opening dispensaries shortly. These states were the trial programs and the facts don't lie. In these states marijuana has been taken off the black market and put into a regulated and controlled environment while providing these cash-strapped states with crucial sales tax revenue.

Indeed, passing this bill will create a trial period but it won't be for dispensaries. It will be the continued trials and tribulations for Hawaii's medical marijuana patients who are forced to turn to drug dealers to get their legal medicine. It will be the continued trials of criminals growing marijuana on public land rather than in clean, secure, and controlled warehouses. We made the right choice eleven years ago when we recognized the medical use of marijuana. Please make the right choice today by treating marijuana like medicine instead of an illegal street drug. We strongly urge this committee to amend this bill back to its SB1458 SD2 form. Thank you for this opportunity to testify.

The House version is needlessly restrictive (experience in Colorado and New Mexico has shown that states can regulate dispensaries without the need for a "pilot project") and the proposed 30% tax is ridiculous and exorbitant for a medicine not covered by insurance (standard excise tax would be more appropriate). Let's be honest here: the House version is just trying to further obstruct the will of the people and the inevitable trend, and it's wasting money the longer these delaying tactics are used. Medical marijuana patients have a reasonable right to purchase their prescriptions from an approved source, not suddenly have to learn farming or risk the black market. The Senate's vision of regulated dispensaries throughout the islands, not just on Maui, would allow plenty of control for the state—isn't that a main concern for law enforcement. We need to go forward with this and stop the foot-dragging.
