SENATE BILL NO. 1513 RELATING TO AGRICULTURE

Chairperson Nishihara and Members of the Committee:

Thank you for this opportunity to provide testimony on Senate Bill 1513, which proposes to eliminate the application and license fees for milk producer, producer-distributors and distributors. The Department of Agriculture opposes the bill.

The legislature enacted the Hawaii Milk Control Act, created to ensure stability and fairness in the local dairy industry and producers are compensated in a fair manner for the milk they produce. License fees are assessed to cover all costs to administer the Act, through the Milk Control Program. Elimination of fees will result in the demise of the Milk Control Program and reduce the ability of the department to assist the producers. Without the administration of the Act, the processor can conceivably pay producers any price they choose for locally produced milk. If this price does not cover the cost of producing milk, which includes a fair return on investment, the dairies will go out of business. This may result in no local milk, and the State will be totally dependent on imported milk.

Furthermore, Sections 4-60-4 and 4-60-5, Hawaii Administrative Rules allows the department to suspend the collection of license fees or lower the fee rate if sufficient funds have been collected to meet the expenditures within a fiscal year.

Chair Nishihara and Members of the Senate AGL Committee:

My name is Glenn Muranaka, President and General Manager of Meadow Gold Dairies. Our company has been in Hawaii since 1897—114 years, providing Hawaii consumers with a variety of milk products and juices. Meadow Gold's long history has not come without effort. We continually adapt to our customers' and consumers' ever-changing needs, and we constantly evolve along with our industry, our community and our market. Over the years, this has required that we struggle, tighten our belts, innovate and work extremely hard, making us a better company in the process. The foundation of this work rests with the 350 employees that are committed to providing superior quality products.

We support the intent of this bill. Over time, we have seen the decline of a once vibrant dairy industry that fell from 60 to now only two farms. There are many challenges to successful dairy farming in Hawaii, ranging from feed costs, water, land, suitable climate for milk production, and selling local milk at premium prices.

Amendment Offered:

Rather than eliminate the licensing fee as proposed in SB1513, a redirection for the use of the fee is suggested. As a processor who contributes \$8,000 a month license fee to the fund, Meadow Gold would be willing to continue contribution if the Milk Control Special Fund expenses were only limited to promotional expenses or other improvements for the dairy industry. In this way, the collective dollars can be used to promote local milk consumption and assist with improved technologies or other needs of the farmers.

Senator Nishihara and Members of the Senate AGL Committee:

I am Bahman Sadeghi, President of Island Dairy, located in Ookala, Hawaii Island. We have a dairy farm of 1,500 cows on 2,500 acres. Our locally produced milk, Hawaii's Fresh, supplies Hawaii Island schools and community, and is available on a limited basis on Oahu. I am in Florida at this time and cannot be present to testify.

We appreciate this bill because it does two things:

- 1) It re-examines the need for license fees when there are only two dairies in Hawaii.
- 2) It also raises the question of why funds from milk producers are collected to support the operating costs of administration when no other commodity has fees collected for such administrative support.

I would be interested in continued discussion about paying the license fees if such fees are only used to support promotional expenses or other improvements to improve the dairy industry. As an individual dairy farmer, it is difficult for me to finance marketing efforts on a continuous basis to increase local milk consumption. However, I believe that if such funds were collected and used to promote local milk, regardless of individual brand, more Hawaii residents would look for and buy local milk.
