TESTIMONY ON SENATE BILL NO. 1522, S.D. 1, RELATING TO DOGS.

TO THE HONORABLE CLAYTON HEE, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Celia Suzuki, Acting Licensing Administrator of the Professional and Vocational Licensing Division, Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to testify on Senate Bill No. 1522, S.D. 1, Relating to Dogs.

Senate Bill No. 1522, S. D.1, creates a new chapter to regulate large scale dog breeders. Section 26H-6, Hawaii Revised Statutes, requires that new regulatory measures being considered for enactment be referred to the Auditor for a sunrise analysis before any measure is enacted. The statute further requires that the analysis shall set forth the probable effects of regulation, assess whether its enactment is

consistent with the legislative policies of the Hawaii Regulatory Licensing Reform Act, and assess alternative forms of regulation.

Therefore, the Department strongly supports a sunrise study on this measure, as mandated by law, before regulating large scale dog breeders. Thank you for the opportunity to testify on Senate Bill No. 1522, S.D. 1.

Founded in 1884, the American Kennel Club is a non-partisan, not-for-profit purebred dog registry and educational organization dedicated to promoting responsible dog ownership, advocating for dogs as family companions, advancing canine health and wellbeing, and working to protect the rights of all responsible dog owners. The AKC represents over 5,100 dog clubs nationally, including 46 clubs in the state of Hawaii.

The American Kennel Club (AKC) abhors the mistreatment of animals and is very concerned about dogs that are kept in cruel, neglectful conditions. We support full enforcement of current Hawaii Revised Statutes §711-1100, 711-1108.5 and 711-1109, which provide for the prosecution of animal cruelty.

We are very concerned with several provisions of SB1522 that seek to create regulations that may be harmful to the wellbeing of dogs, limit the number of dogs that may be owned, and impose unnecessary licensing and other requirements on small hobby breeders. Concerns about SB1522 include:

- Low regulatory thresholds and vague definitions This bill would require licensing as a "large-scale dog breeder" by:
  - o Persons who sell 25 or more offspring of breeding female dogs in any one-year period. For owners of large breeds, this 25 puppy threshold could be exceeded with two litters, and would trigger the requirement for licensing even if no puppies were sold in prior and succeeding years. A person who owns two female dogs and breeds each dog one time could meet the threshold for licensing, regulation and inspection as a "large-scale dog breeder."
  - Owners of 20 or more intact female dogs or 30 intact dogs of either sex over the age of six months that are "intended for breeding." There is no definition of how intent is determined.
  - Issuance of a license would require prior approval of the appropriate county department of planning and permitting. Under the definitions in this bill, there would be no differentiation between a hobby breeder who produces a small number of puppies in the home and a large commercial kennel.
- Infringes on property rights This bill would prohibit a licensee from owning or harboring more than 50 intact dogs on a premises. Laws that limit animal ownership are ineffective, arbitrary, and do not address the underlying issue of responsible ownership. Limiting the number of animals a person may own will not automatically make them a better owner. Furthermore, both the dogs and Hawaii taxpayers lose, as responsible owners may be forced to give up their dogs to a local shelter in order to comply with the limit, and the dogs will be housed and/or euthanized at great cost to local communities.

Establishes potentially harmful requirements – This bill would establish numerous requirements for dog care, housing and enclosures that do not take into account a dog's breed, age, or condition. This bill could also make illegal the safe confinement of dogs indoors.

- o "Constant and unfettered access to an outdoor exercise area" is not reasonable because:
  - This regulation could prove lethal to aged or ill dogs and to young puppies that need protection from extreme weather.
  - Dogs can effectively be exercised and kept in proper physical condition without "constant and unfettered access" to the outdoors.
  - This requirement would prevent a responsible owner from confining dogs indoors in the evenings so that barking and other noises do not create a nuisance.
- An indoor temperature limit of 85 degrees is contraindicated. Newborn puppies may require higher temperatures to thrive.
- Allows for unannounced inspections This bill would provide for unannounced inspections during business hours of areas in which dogs are kept, handled or transported, with no limitations regarding the inspection of private homes where dogs are kept. This is particularly egregious to small hobby breeders who raise puppies within the home, and do not keep "business hours".
- Provides for adoption of additional rules subject to excessive civil penalties This bill provides for civil penalties of \$1,000 a day for licensing violations and \$1,000 per citation under these and any future rules as determined by the Director of Commerce and Consumer Affairs.
  - The AKC recommends that any oversight and rulemaking for animal breeding should fall under the jurisdiction of a department with expertise in animal husbandry such as the Department of Agriculture.
  - o The AKC strongly advocates that any measure that requires the adoption of rules for dog breeding facilities and dog care should also require participation in the rulemaking process by experienced dog breeders. Input is needed from dog owners who are knowledgeable about breeding, raising and maintaining the various breeds of dogs.

Further, the creation of additional bureaucracy and cost for taxpayers in Hawaii is not warranted based on infrequent cases of animal abuse by irresponsible dog owners that can be resolved under existing laws. When conditions of abuse or neglect are found, animal abusers can be dealt with effectively through strict enforcement of existing cruelty laws, regardless of the reproductive status of the dogs or the number owned.

We respectfully urge the Senate Committee on Judiciary and Labor to reject Senate Bill 1522, and instead focus on full enforcement of current animal cruelty laws.

The AKC and our dog clubs in Hawaii would welcome the opportunity to work with you to develop effective, responsible legislation and public education programs designed to promote and encourage responsible dog ownership.

While it is desirable to close "puppy mills" which cause misery for countless numbers of dogs-both the breeding dogs as well as the offspring which are kept in confined, unsanitary spaces with little or no human contact- SB1522SD1 is not the legislation to accomplish this goal. SB1522SD1 unnecessarily punishes the hobby breeder whose mission is to improve a specific breed by careful breeding and raising of quality puppies for conformation, pet placement and service dog training. The way to accomplish the goal is to regulate large scale wholesale and retail sale of puppies through pet shops as well as on the internet rather than setting an arbitrary limit. Animals should have proper documentation of veterinary care as well as having the point of sale reveal the source of the animals. That way, prospective dog owners can check the facility prior to purchasing an animal and the number of animals placed for sale through retailers will be known. As the Hawaiian Humane Society raid on a puppy mill in Waimanalo just showed, the regulation of puppy mills can be accomplished by enforcing existing laws.

Our society has a responsibility to make certain all animals are treated with kindness and care throughout their lives. They deserve love and attention, training and medical care. RE: Testimony in SUPPORT of SB 1522; Relating to Dogs

My name is Christel Collins, and I strongly urge you to pass SB 1522, pertaining to commercial dog breeding.

This law is needed to prevent the cruel and inhumane exploitation of dogs in Hawaii. For many people, dog-breeding is a quick way to make money, and the welfare of dogs is a low priority.

This bill would provide some measure of protection for some of our most helpless island residents.

Here are just a few examples of my very limited experience with puppy mills, all occurring within the last few months:

- 1. Recently, I went to Petco in Pearl City. I noticed all the puppies for sale, with the cheapest selling for \$200. As I went around the store, I noticed that there were two 'no-kill' organizations in the store, introducing their foster dogs to possible adopters. I chatted with one of the volunteers and asked her about the dog she was playing with. He was an older dog with a large 'adopt me' kerchief around his neck. The volunteer told me he was a rescue dog from a local puppy mill. He had been found with 10 broken teeth, and had little or no socialization with humans. His sole function was to inseminate female dogs so people could sell puppies. It was terrible to realize that the no-kill organizations were trying to find homes for the worn-out progenitors of the puppies selling like hotcakes in the same store.
- 2. This evening a co-worker who sometimes volunteers at the Hawaiian Humane Society told me that she had just received a text from them asking for help with grooming. They had just received 150 dogs from a puppy mill. I have adopted all my dogs from the Hawaii Humane Society and I know they don't have room for 150 dogs. Many will be offered for adoption, others will be farmed out to no-kill shelters, and others will be euthanized. What a tremendous burden has just been assumed by already-overwhelmed organizations because of the irresponsibility of the person who 'owns' these dogs.
- 3. One of my neighbors breeds small dogs to sell. He usually has six small dogs and at least three are constantly pregnant. They are kept in a pen of approximately ten feet by ten feet. The pen abuts the sidewalk, which is next to one of the busiest streets in town. He sells the puppies for \$150.00 each. Unfortunately, he would not be affected by this bill since he doesn't have 50 intact dogs.

Chairman Hee, thank you for introducing this bill. Because you did, I know that you take your responsibility as a legislator seriously. I trust that Vice-Chair Shimabukuro and Senators Gabbard, Slom, and Ihara will join all of us who protect those who cannot protect themselves.

This is in regards to SB1522 D1 to be heard on March 1st at 9 a.m. in Room 16 of the State Capitol in Hawaii.

- We are all in agreement that puppy mills should be shut down and prevented. The
  intent of SB1522 was to regulate the retail sale of puppies by large commercial dog
  breeders, however the bill, now amended, will regulate all dog breeders and
  establishes arbitrary limits on dog ownership regardless of the care and nurturing the
  dogs receive.
- City & County zoning laws already establish limits on the number of dogs allowed on residential properties (10). These laws are often already being broken by puppy mill operators and not enforced. SB1522 D1 now establishes a precedent on agricultural zoning and animal ownership (ranchers and farmers should be concerned about this).
- As presented, SB1522 D1 is a deterrent to hobby breeders and dog fanciers.
   Responsible hobby breeders seldom profit from their breeding programs (costs of quality animals, vet costs, costs for health clearances, stud fees, cost of whelping and raising a litter). There is a need for hobby breeders producing quality dogs because many pet owners want a certain type of dog, with a certain temperament and health guarantees. Additionally, animals used for service and therapy work need to be of a particular type and termpement.
- Limit laws are very difficult to enforce and can easily be evaded by irresponsible pet owners. Limit laws have been shown to decrease the number of dogs licensed, and the number of dogs who receive regular veterinary care because of reporting.

Additionally, people who are forced to give up their dogs usually end up taking them to the local shelter which increases the number of dogs needing to be adopted.

- SB 1522 D1 also establishes unrealistic engineering requirements for dog housing which do not take into account a dogs breed, age, health, or condition.
- Legislation needs to focus on the number of puppies which are sold to retail outlets, which includes the internet by large scale commercial breeders. These breeders need to be licensed with yearly inspections to determine the care and health not only of the puppies being sold but the dogs which are being bred. Pet stores should be required to report where their dogs are obtained from as well as basic health and medical information.
- The Animal Welfare Act already requires that wholesale sellers must be licensed, which is not being enforced in Hawaii.
- Regulation focusing on limits and not wholesale or retail licensing will only shut down the small hobby breeders who are committed to their fancy.
- An argument will be made that there are already too many dogs which need to be adopted. The truth of the matter is that a high percentage of these dogs may not be appropriate for families which are looking for a certain type of temperament, size, and kind of dog. A very large percentage of the dogs in our local shelters are pit bull mixes which are not easy dogs to place in a family environment.

I sincerely hope that you will reconsider this bill.
