TESTIMONY ON SENATE BILL NO. 1527, RELATING TO NATIVE HAWAIIAN HEALERS.

TO THE HONORABLE BRICKWOOD GALUTERIA, CHAIR, AND TO THE HONORABLE ROSALYN H. BAKER, AND MEMBERS OF THE COMMITTEES:

My name is Celia Suzuki, Acting Licensing Administrator of the Professional and Vocational Licensing Division, Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to testify on Senate Bill No. 1527, Relating Native Hawaiian Healers.

Senate Bill No. 1527 creates a new chapter to regulate Native Hawaiian healers.

Section 26H-6, Hawaii Revised Statutes, requires that new regulatory measures being

considered for enactment be referred to the Auditor for a sunrise analysis before any measure is enacted. The statute further requires that the analysis shall set forth the probable effects of regulation, assess whether its enactment is consistent with the legislative policies of the Hawaii Regulatory Licensing Reform Act, and assess alternative forms of regulation.

Therefore, the Department strongly supports a sunrise study on this measure, as mandated by law, before regulating Native Hawaiian healers. Thank you for the opportunity to testify on Senate Bill No. 1527.

Testimony on Legislation relating to regulating Native Hawaiian Healing

Senate Bill 1527

Aloha members of the Senate Committees on Hawaiian Affairs and on Consumer Protection:

I oppose this bill on two fundamental grounds:

- a) the elevation of Western academics above native practices; and,
- b) the contradiction to the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) which was recently approved by the U.S. administration of President Barak Obama.

On Western academics, the bill provides, inter alia,

- § -6 Qualifications for examination. Before any applicant shall be eligible for examination under this chapter, the applicant shall furnish satisfactory proof to the board that the applicant has been awarded a bachelor's degree or higher degree in Hawaiian studies or an equivalent degree, as determined by the board pursuant to rules adopted under chapter 91, that includes an accredited course of study in native Hawaiian healing from an accredited college or university.
- § -7 Board of native Hawaiian healing. There shall be a board of native Hawaiian healing consisting of five members appointed by the governor pursuant to section 26-34 which shall be attached to the department for administrative purposes only. Of the board members, three shall be native Hawaiian healers licensed under this chapter, and two shall be private citizens.

If the impact upon native Hawaiian practices were not so serious, the proposal in the above sections would be hilarious. Especially when dealing with the practice of La`au Kahea, Puke (or Paipala) Wehiwehi, Noho, Oki, etc. a Western degree is not seen as the basis of one's competence in the practice.

On the UNDRIP, consultation with the native people affected should first be done before any governmental action is taken in this area. This bill makes no reference to such consultation.

This bill should not be passed in its present form.

#### TESTIMONY AGAINST SB1527 RE: Native Hawaiian Healers

### Dear Hon. Legislators

I am Terry Shintani, MD, JD, MPH, President of the Hawaii Health Foundation and Associate Chair of the Dept of Complementary and Alternative Medicine at the John A. Burns School of Medicine. I speak here only for myself and the Hawaii Health Foundation. I am one of the main authors of Act 304 of 2001 which created the "Certification" for the exemption from HRS 453-1 which has worked to currently allow Traditional Hawaiian Healers to practice their art. I am in opposition to SB 1527 Re: Native Hawaiian Healers and any companion bill in the House. Here are some of my concerns about this bill.

- 1. I suggested that this be run by the healers' kupuna councils before it was drafted. This would be in keeping with Traditional Hawaiian protocol. It appears that this was not done so now there is resistance. Part of the problem is that Certification/Licensing seems disjointed and ignores the sitting Kupuna Councils. In doing so, it is becoming a divisive issue. This is unfortunate at a time when there is no energy to waste on battles. Instead, all the energy should be focused on elevating the healing arts and making progress based on what has already been done. The proposed bill does not build on the current system as Alyce Dodge suggests. If that were true, they would have consulted with people in the current Certification system and created a joint approach starting with the current Councils as the basis of Certification/Licensing.
- 2. The argument about the future generations employment doesn't hold water. The current system allows for employment of future generations right now. That was part of the intent of the original Act 304 of 2001 that created the Certification. A young person could be Certified and open a practice right now. In addition, if they did so at a community health center, they could have Federal Tort Claims coverage for malpractice. If the concern is reimbursement, licensing is not the answer. Currently licensed practices such as Acupuncture and Naturopaths is generally not reimbursed anyway. Despite this they can make a fine living. I believe a more sensible answer is getting the insurance companies to reimburse Certified healers under the existing system or in the alternative bringing Certification to be the criterion for "Licensing". This would be better for neighbor island practitioners who then would not have to fly to Oahu for classes. They could be Certified by their own local Kupuna Councils.
- 3. The original Certification bill (Act 304 of 2001 SB 1390 or its predecessor) I believe has regulations in place (I believe in committee notes) about the setting of and continuation of the Councils that are similar to those proposed. Why create a new set?
- 4. I think the best approach is to use the current Kupuna Councils and their Certification as the basis of licensing rather than reinventing the wheel. You could simply refer the sections on the requirements of licensing to the Kupuna Council and Certification process and the system would be in place right now. If you want reimbursement, just get reimbursement for individuals who are Certified or convert the Certification process into the Licensing process and get reimbursement for that form of licensing based on what is already in place.

I write in opposition to SB 1527.

We, Kupuna and Hawaiian Traditional Practitioner Council members of Hui No Ke Ola Pono, Maui, have been working long and hard since the 1980's to bring Hawaiian traditional practices to where they are today. Practitioners set a tone and direction that legitimized the practice and brought honor and integrity to the process in line with traditional practices. State laws were passed during the Cayetano and Lingle administrations to legitimize those standards.

The licensure of Hawaiian Studies students in any traditional practice cannot be compared equally with the schools of Architecture, Engineering, Law, and Medicine. For the promoters of this process to say that "....la'au lapa'au in Hawaii has always been and is still looked upon as mere quackery, surrounded by ritual..." is a reckless statement and a devastating blow to many of us that have practiced for decades and have strived to enlighten others and our own people about the legitimacy of who we are, what we practice, and the ancestors we truly represent.

SB 1527 basically destroys all that work and effort and takes our practice out of the cultural and into the Western arena. This is a very serious undertaking that must be brought to the Hawaiian people, the traditional practitioners and kupuna for input. We need to have consensus among the Hawaiians or this will create a double standard and again divide us as Hawaiians.

Any accreditation program must go far beyond just the development of course content in Hawaiian Studies and a review by a curriculum committee. This legislation is calling for the creation of licensed professionals and its standards and code of conduct must be reviewed by experts and others of much higher wisdom and experience. Why is the curriculum, research and practice not published for proper scrutiny and review by kupuna, the Hawaiian people, and appropriate practitioners? Why are only "...qualified practitioners through the University

system..." and not the traditional practitioners included in setting standards and screening applicants? As we kupuna always say, why does this process **not pass the smell test** and seem **"kapulu"**?

This law is seriously flawed and must be defeated and sent back to the Hawaiian people for review. There is no need to rush this bill through the legislative process without taking a very serious look at how it will affect thousands of years of practice as well as an entire culture. We can work on this bill together and come back next year with a more appropriate and culturally correct bill if needed.

I speak on behalf of our Kupuna practitioner council, Hawaiian traditional practitioners on Maui and on behalf of myself as a student and practitioner for over 50 years.

E kala mai, I am traveling and lecturing on Hawaiian healing and culture in Austria and cannot make my plea in person.

#### TESTIMONY IN OPPOSITION TO S.B. 1527

I am Gerald Nalikokalauokalanike'alohilanikikaupe'aokalanikapahupineakaleikoakeopuhiwa-a-Paki Yun Chin Lam. I am a Traditional Native Hawaiian healing practitioner trained through genealogical priesthood in laau lapaau by my grandmother Alina Paki and grand aunt Luka Kinolau from 1955 – 1987; and, through uniki in November 2000 by Papa Henry Auwae. I have been a recognized Native Hawaiian practitioner of traditional Hawaiian healing arts in Hawaii since 2001. Born and raised in Honolulu, I have been a practicing attorney since 1976 and served as a jurist in District Court, First Circuit from 1982 - 1988. I served as President of the Native Hawaiian Health Care System (Papa Ola Lokahi) and as President of O'ahu's Native Hawaiian Health Care System (Ke Ola Mamo). I strongly oppose SB 1527 relating Native Hawaiian Healers and strongly urge that SB 1527 be held in Committee for the following reasons:

- The practices created under Senate Bill 1527 are not traditional native Hawaiian healing practices but, instead, a new Western medical profession that directly violate previous State legislation. Traditional native Hawaiian healing practices are long recorded by the Legislature as authorized solely by Ke Akua (God) pertinent to Act 162 of 1998 and ensuing legislative amendments in 1999, 2001 and 2005. Practice under SB 1527 in "personal health care of individuals based on traditional native Hawaiian practices" is not by definition traditional Native Hawaiian healing practice. Therefore, the SB 1527 "Hawaiian healer" cannot be presumed to be a "Native Hawaiian healer who practices native Hawaiian healing." By previous legislative reference, no human induced vehicle can substitute or usurp God's divine authority through legislative definition of our sacred practices. SB 1527 definition "Practice of native Hawaiian healing means personal health care of individuals based on traditional native Hawaiian practices" can never equate to laau lapaau, laau kahea, lomilomi, ho'oponopono or any other traditional Native Hawaiian cultural healing practice. SB 1527 legally fails considering Hawaii State Constitution Article 12, Section 7, Act 162 of 1988, Act 153 of 2005, and Hawaii Revised Statutes 453-2(c). Statutory professions based upon otherwise genuine culture are Frankensteins polluting traditional indigenous practices. Failure to first clearly establish a compelling need to protect against imminent public danger violates the State constitutional rights of all Native Hawaiian healing practitioners.
- 2. SB 1527 proposes a consumer fraud. Government licensing is irrelevant, immaterial and currently nonexistent in traditional Hawaiian healing practices. Hawaiian healing arts and practices are not amenable to Western scholarship or science. This is established in the Legislative Comments and history pertinent to Act 162 of 1998 and ensuing amendments. Our indigenous cultural healing practices can neither be defined and regulated by a State Board, nor qualified by secular exams presuming to categorize and quantify a universal standard among priestly traditional practitioners. SB 1527 self-authenticates itself as "native Hawaiian healing," but, in fact, is not the traditional native Hawaiian practice to which it refers. SB 1527 merely disguises a Western profession as "based on" genuine traditional native Hawaiian practices. Therefore, an entirely new practice of medicine is proposed that induces a false presumption in consumers. SB 1527 licenses college graduates to practice priestly arts even though a secular college is not competent to certify divinity and prayers.
- 3. <u>Collegiate academics are not proper venues for producing Native Hawaiian priests and priestesses called by God to publicly practice sacred arts.</u> A secular university or college may produce historians, but not priestly culturalists. A secular college is not competent to train and produce sacred traditional healing practitioners. Hawaii healing is a priesthood calling from God alone through genealogical qualifications not congruent with the Western notion of meritocracy. Where it is proper for colleges to study <u>about</u> our sacred cultural practices, it is not acceptable for colleges to employ <u>in</u> our traditional sacred practices. As law, SB 1527 proposes the complete absence of any Native Hawaiians on the Board of native Hawaiian healing. Self-determination by Native Hawaiians will give way to the competing outcry of unconstitutional racism assuring genocide of Hawaii's indigenous culture.

- 4. State licensing of native Hawaiian healing defrauds native Hawaiians of their intellectual property.

  Native Hawaiians view the issue of self-determination as a political rather than racial matter. Native Hawaiians fight the genocide that they believe is assured through Western control over cultural practices that define their indigenous identity. Licensing of sacred cultural practices is a matter for an indigenous Hawaiian sovereign entity. SB 1527 is prematurely reckless in proposing a new practice of medicine (as chiropractic, acupuncture, and naturopathic have historically) based on indigenous cultural practices. SB 1527 can as easily be based on Ayurvedic healing practices from India through the University of Hawaii.
- 5. The enactment of SB 1527 will divide Hawaiians and add a third division of non-Hawaiians disputing priesthood rights. SB 1527 restricts practice as a "Native Hawaiian healer" to college graduates in Hawaiian studies determined by a prospective board of non-Native Hawaiians. Not even the native Hawaiian masters of traditional practices and oral traditions across generations qualify as "Native Hawaiian healers." Baccalaureate Hawaiians without priesthood birthright will claim entitlement over Hawaiians of birthright training. And, the colonization of Native Hawaiian resources by migrant baccalaureates will become a presumed protection under the U.S Constitution. SB 1527 promotes the position that Native Hawaiian self-determination is a racial rather than political matter.
- 6. Prohibitions upon "traditional practitioners" violate constitutional fairness. SB 1527 usurps every semantic, cultural reference, term and description concerning every sacred traditional healing practice, and, then, places restricts upon all traditional practitioners who default into its statutory exemption. Traditional healers are unconstitutionally deprived of their preexisting rights. Currently, traditional Hawaiian healing practitioners are not prohibited from representing the nature, qualifications and qualities of their capacity. Current laws guarantee traditional Native Hawaiian practitioners autonomy against unreasonable government regulation.

I would like to testify in support of SB1527. I am a member of the University of Hawaii (Mānoa) La□au Lapa□au class. I am interested in and supportive of Hawaiian Herbal Medicine, personally, for several reasons. First, I respect the knowledge of the □āina and its plants and their uses that the Hawaiian culture and its kūpuna have gained over hundreds of years. This is a priceless and irreplaceable gift to us all. It is also important to me that I have an alternative to drug companies and their products. They can be of benefit of course, but I want to have the option to use something that is closer to nature. For instance, when you harvest and use a plant you get more than one active ingredient. Each plant comes with many different components. These components, working synergistically, give a result that is more balanced so that there are fewer side effects than with medicines manufactured to provide one unopposed ingredient. Also, when you harvest and use your own plants you know where they came from, how they were grown, and how they are processed. It is reassuring to me and also better for the Earth.

#### S.B. 1527: Relating to Native Hawaiian Healers

Chairpersons Galuteria, Baker & Members of the HWN/CPN Committees:

I am Sunny Alonzo Greer from Kahana, Oahu. I am a practitioner of traditional Native Hawaiian healing as taught to me by my kumu & kupuna, the late Pookela Laau Lapaau Papa Henry Auwae. I am also a member of Na Lei Hulu No Ke Ola Mamo & the Kupuna Council of Koolauloa Community Health and Wellness Center, two kupuna councils recognized by Papa Ola Lokahi (POL).

#### I strongly OPPOSE S.B. 1527: Relating to Native Hawaiian Healers.

Please read POL's Interim Report to the State Legislature in Regards to Act 162, Relating to the Practice of Medicine (January 1999). The Report summarizes the October 1998 meeting of 5 respected kahuna, wherein my kupuna served as its Chairman. POL convened the kahuna to "discuss the question of "recognition" and "certification" of practitioners of traditional Hawaiian healing practices as part of the concern for uniform professional standards associated with the respective healing arts."

#### According to the Report:

It was uniformly felt that it was not state government's role or responsibility to 'recognize' or 'certify' practitioners of traditional Hawaiian healing practices. All of the kahuna who have public programs instructing individuals in the traditional healing practices have certification and recognition processes in place ... From the days of the Kingdom, then Territory, and now State, the various governments have attempted licensure of practitioners of traditional Hawaiian healing practices, and all efforts have failed (emphasis added).

By its very nature, this bill disrespects the fundamental teachings of traditional Native Hawaiian healing practices. Spirituality and one's genealogy are fundamental tenets in our practice, not Western-based selection, education and examination. This bill is an affront to the customs and rituals of true traditional practitioners, as it elevates Western processes and denounces traditional Native Hawaiian protocols.

This bill proposes to usurp cultural kuleana handed down from generation to generation and transfer it to an appointed government board. This means that a government board is deemed more knowledgeable in traditional Native Hawaiian healing practices rather than traditionally-trained practitioners. In 1948, a Board of Examiners for Hawaiian herbalists denied a license to noted kahuna Luka G. Kinolau of Laie, Oahu because she did not know the botanical names of the plants she used. Will this happen again? Aue!

This bill also requires a "bachelor's degree or higher degree in Hawaiian studies or an equivalent degree" in order for all applicants to qualify for licensure. Under this bill, <u>NONE</u> of the respected kahuna convened in 1998 by POL would be qualified to even apply. This bill essentially renders invisible the *true* practitioners of traditional Native Hawaiian healing practices. I suspect this bill is an attempt to define and legitimize the practices of those who aren't.

I urge you to please hold SB 1527 in Committee.
