The growth of Oxford Houses in Hawaii is a testament to the dire need of Sober Housing for people in recovery from substance abuse. We will join the task force and seek solutions to meet the state goals.

We will not however compromise the integrity of our program in any way. Through the years, we have helped thousands of people in Hawaii learn how to live sober using the Oxford House method of operations. Our success has been document in research conducted by DePaul University in Chicago Illinois.
