Chair Hee, Chair Ige and Members of the Committees:

The Department of Hawaiian Home Lands (DHHL) supports the purpose and intent of SB 1 SD 1 which provides for the recognition of Native Hawaiians as the indigenous people of Hawaii and establishes a process for the reorganization and recognition of a Native Hawaiian Governing Entity.

DHHL has supported the various versions of the Native Hawaiian Government Reorganization Act that have been vetted in the U.S.

Congress since 2000. The premise for DHHL supporting this federal legislation was achieving federal recognition to protect the Hawaiian Home Lands trust from 14th Amendment legal challenges and to advance Native Hawaiian self-governance and self-determination. We do support state recognition of a Native Hawaiian entity as an intermediate step for Native Hawaiians to ultimately achieve federal recognition, however, our department must further study this measure and engage in consultation with our beneficiaries to fully understand its impact to

RE: THE OPPOSITION of SB1 SD1 by the Hawai'i'miloa Movement.

The Hawai'i'miloa Movement opposes SB1 SD1 as a violation of Articles 43 and 55 of the Hague Regulations (HR) of the Fourth Geneva Convention (IVGC) in regard to the international laws of occupation.

Article 43 of the HR states, "The authority of the legitimate power having in fact passed into the hands of the occupant, the latter shall take all the measures in his power to restore, and ensure, as far as possible, public order and safety, while respecting, unless absolutely prevented, the laws in force in the country."

Whereas article 55 of the HR states, "The occupying State shall be regarded only as administrator and usufructuary of public buildings, real estate, forests, and agricultural estates belonging to the hostile State, and situated in the occupied country. It must safeguard the capital of these properties, and administer them in accordance with the rules of usufruct."

The Hawai'i'imiloa Movement is a coalition of Kānaka Maoli and non-Kānaka Maoli Hawaiian Nationals, both individuals and organizations who recognize the sovereignty of the de jure and de facto government of the Hawaiian Kingdom whose last sovereign agent was Queen Lili'uokalani and thereby have a vested interest in the matters of State.
