I am concerned that this measure is a potential negative impact upon the actual protection of our natural resources. Not everybody belongs to a Hawaiian civic club and I will state that this measure as written is biased.	
Page 1 Line 9 reads: Native Hawaiian culture has knowledge that has been passed on for generations	
Line 9 should read: Native Hawaiian traditional ecological knowledge (TEK) has been passed down for generations	
[The suggested use of TEK would be in sync with the state, federal, and global science community]	
[The usage of passed on sounds as if someone died; passed down is commonly used here in Hawaii and genealogical pedigree is from the top down]	
Page 5 Line 11 and 12 reads: the specific resources located within those areas	
[This usage goes against what we are trying to protect]	
Page 6 Line 11 states: (3) Foster the understanding and practical use of knowledge	
Line 11 should read: (3) Foster the understanding of traditional ecological knowledge (TEK)	

Line 16 should read:

Page 3 Line 16 states: . . . the Northwest Hawaiian islands

... the Northwestern Hawaiian Islands (NWHI) [This would be consistent with state, federal, and global communities]

Page 7 Lines 1 to 3 states:

- (8) Establish an administrative structure that oversees the 'aha moku system; and
- (9) Select an executive director.

[Perhaps I am reading this wrong but I see a state version of WPFMC (Western Pacific Fishery Management Council). The executive director supposedly works for the, in this case, the Commission which I assume would be a paid position.

Where will the funds come from? DLNR's budget? There is no mention of the Office of Hawaiian Affairs and share cost.

This document smells fishy and I would like to recommend to these distinguished committees that ample time be given the public to review the Report to the Legislature from this advisory group on behalf of the host culture.]
