I'm the Site Coordinator for the Benjamin Parker Families for REAL program and would like to provide some background information. Nope you will see the uniqueness of our program as it helps families and young children prepare for school.

This program provides learning experiences for families and their children, from birth-5 years, with the goal of promoting education and making each child's first experience in the classroom a positive one. We are the link between families with young children and the school environment by bringing parents onto school campuses and providing them with the opportunity to become involved with their child's education at the earliest age possible. We have seen a direct correlation between parents who have attended our program and the level of their involvement once their children enter school.

Data from last year showed approximately 270 families and their children from all over the island attended our program. There was also a diverse range of families that we serviced. For example, 11% were grandparents, 13%-dads, 13%-military, 23% had an income under \$38,000, 22% of the children were receiving other services and 33% of the children were part Hawaiian. At the end of last school year, we had approximately 360 families on our wait list. This data represents only the Windward site.

Emphasis should be placed on Early Childhood Education, the formative years, yet this program lost its DOE funding. We need to invest our time and money to ensure all young children have the opportunity to learn and succeed.

By being proactive we can provide parents with information and resources about child development and school readiness. We also provide their children with experiences that will enhance their development and learning. If we can offer this to families, more children will enter kindergarten developmentally ready to learn. This will lead to long-term school & life success.

The only way for Families for R.E.A.L to continue serving parents and their children, as we have done for the past 19 years, is for the legislature to pass SB289.

Please, we ask you to consider our request and think about the future of our children. & THE FUTURE OF HAWAII

My name is Laura McHugh and I am the site coordinator and parent educator for the DOE Leeward Families for R.E.A.L. (Resources and Early Access to Learning) program at Pearl City Highlands Elementary School. I am here to ask for your support of SB 289, a bill that would provide biennial funding for Families for R.E.A.L. (FFR).

FFR has been operating since 1988 and its mission is to support parents in their role as their child's first teacher. Although the majority of our participants are typical parents and *there are no restrictions to attend*, FFR also serves families who are referrals from agencies such as 0-3 (DOH Early Intervention Section), Easter Seals, Family Court, and CPS. There are currently two FFR sites (down from 5 sites just 3 years ago), Leeward and Windward, and each site serves approximately 300 families every school year with at least that many more families on a waitlist.

Research shows that 90% of brain development occurs within the first 5 years of life. FFR is a very important parent-child interaction program that provides practical and useful information necessary to build healthy families. Our goal is to get parents to be more involved in their child's education by giving them the tools they need such as information on child development, and share ideas for activities and other ways they can help their child in the critical early years of development.

FFR is a vital program that provides school-based curriculum for parents and their children birth to 5 years of age. The Department of Education (DOE) believes that FFR does not "directly service" the children of Hawaii; therefore, it has cut funding for this very important curriculum-based program. This decision jeopardizes the opportunities that will provide for the healthy development of Hawaii's keiki and help them be "school ready" when they enter kindergarten. For that reason, I humbly ask for your support to continue funding FFR.

I am a parent of two children in District 22. I am currently on extended leave from my Department of Education duties (former Iliahi Elementary School Technology Coordinator, Ka*ala Elementary School Curriculum Coordinator, and most recently, as a School Librarian at Sunset Beach Elementary School) to "raise" my babies until they are of school age. My girls are 2 * and almost 4 years old.

I am writing to encourage you to support funding for the Families for R.E.A.L. program as described in S.B. 289.

Having 20 years of teaching experience, and now, being a mom – I am sharing my concern as both parent and Department of Education employee. Research has proven the importance of "parents as their child's first teacher" and yet, so many parents are ill-equipped to "teach" these little ones. Even with my teaching background, I found myself floundering and wanting help. There are so many programs available for selected groups of people. Unfortunately, my family does not fall into any of these categories. Low income families have opportunities to apply for early education programs and financial assistance. Hawaiian children have programs and designated schools. Children with special needs have "some place" to go. My children almost had no where to go – until we were able to attend Families for R.E.A.L. This program is not limited by economic, ethnic, or specific-need criteria.

As described in S.B. 289, Families for R.E.A.L. is a parent-participation program. Two components run simultaneously. The child is in a stimulating learning environment, engaged in activities that directly tie into building blocks and foundations for meeting Hawaii Content Standards: literacy, problem solving and reasoning, math, science, art, and music, etc. The parent participates with the child for circle time (routines, singing, and reading time) and an art activity, and then is involved in the adult learning time: parenting topics/resources.

Hawaii has already lost all but one site, due to lack of funding. S.B. 289 will enable Families for R.E.A.L. to continue to impact future generations. If you have time in your busy schedule, I urge you to stop by to see the amazing learning taking place at Families for R.E.A.L. on the Pearl City Highlands Elementary School campus. If you have any questions or need more details, please feel free to contact me.

The future of Families for R.E.A.L. is in the hands of the Hawaii Senate and Legislature. As a member of the Hawaii Senate, I urge you to support S.B. 289.

Educational, Effective, Necessary. These are the words that accurately describe the State of Hawaii, Department of Education program, Families for R.E.A.L. under the direction of Ms. Laura McHugh and her two classroom aides.

.....

I first learned of Families for R.E.A.L. at Keiki Tuesday which is held at Pearlridge Shopping Center. There were several stations set-up at the hour-and-a half session which included separate tables for: a mini library, puzzles, playdough, and two craft activities. The crafts were useful, fast and easy take-home pieces.

The demand for this program is so great that we were on a wait list for eight months before we were offered the chance to attend.

A typical Families for R.E.A.L. day begins with "circle time", when children and adults sing and dance to welcoming songs and nursery rhymes while accompanied by an ukulele strumming teacher. Then there is a storybook reading. Each week, adults and children do a hands-on project together like bracelet making, preparing a snack, bubble play, child's handprint with poem and making a seashell paperweight. The short ninety minute period is well planned. We will go on three field trips to Hoomaluhia Botanical Gardens, the Zoo, and the Dole Plantation Train Ride. There is also a tentative field trip scheduled to Pearlridge Shopping Center for a day at Keiki Tuesday.

The adults then separate into their own group to share and to receive ideas, suggestions and guidance on topics on child development, child's play, play and learning recipes (make your own playdough, sugar chalk, colored rice and bubbles), regulating television viewing, reading to your child, child independence, social-emotional development, relationship-building skills, methods of effective discipline, childproofing the home, setting limits, expressing feelings, logical consequences, managing and coping with stress, and tips for just enjoying our toddler. We received TONS of resources to look at on our own.

In the meantime, the children are busy with activities like hala seed painting, fruit printing, box car painting, cookie cutter stamping, blow w/a straw painting, flower stamping, fish prints, and just playing with the many interesting toys and play equipment. They even have their own dishwashing area where they actually soap, rinse and dry their own dishes.

Success of the program also relies on supplies gladly donated by parents/grandparents due to the dedication and the sincerity shared with all of us by Ms. McHugh and her staff. Please help us to help our young ones. In addition, expansion of this excellent program to accommodate a greater number of families would do our society a world of good. My view is that we should groom our children as youngsters, rather than taking care of them in prisons. It just makes so much sense to keep Families for R.E.A.L.





Toddler sessions at *Families for R.E.A.L.* have provided us with weekly fun time and learning activities for both the parent/caregiver and child to do together. On Oahu, it is difficult to find such a program which provides this need as a very first step to childhood education. In our case we come from Manoa for these sessions at Benjamin Parker Elementary School.

A first time experience has been hand printing and coloring on a T-shirt. My granddaughter approached printing with lots of apprehension and exploration as I helped her by placing her hand on the print pad and pressing it onto the fabric. Through this activity I became aware that hand printing and painting are some things we can begin to do together at home to develop a sensory awareness to the world around her.

Each week a well planned parent and child activity is scheduled from creating a personalized photo place mate, pool fun, a visit to the zoo, five senses awareness are just a few to mention. Along with a parent-child activity the schedule includes singing a variety of songs like a welcome song called *Get on Board*, an old favorite *Eensy Weensy Spider* and ending the time spent with a good-bye song. The songs always provide a routine and good feelings for the children and parents.

Especially helpful for me in caring for my granddaughter is the sharing of professional literature on growth and developing from infant to preschool. I enjoyed when we did a multi-checklist on age appropriate development in the different modalities such as speech, coordination, problem solving and such. On behalf of my daughter and her husband, Kiana and Grant Shiroma, and my granddaughter, Samantha Shiroma, I wanted to express our sincere gratitude and appreciation to both of you for the awesome experiences that you have provided our very first Families for Real class.

Our Toddler Class provided Samantha with invaluable interaction time with other children her age. Over the course of the ten-week session, it was fun to watch her mature from an insecure, unsure baby into a much more comfortable, confident toddler. I remember the first week, being unsure of herself in a new environment, Samantha came to me several times during the adult meeting portion of the class, crying and needed assurances that I was nearby. Besides playing alongside her newfound friends, Sammie's favorite part of class was the group singing portion of class. Linda's adorable handpuppets and paper animals along with Chris' ukulele accompaniment, kept both toddlers and adults interacting and singing. We were delighted to receive our very own CD with our favorite songs recorded by our own class. Now we can listen to them on our car rides and at home too.

Each week, Chris had new, interesting topics of discussion in our adult meetings. I would go home each week, relay the information to

Kiana and Grant and ask them to read the handouts, complete surveys, and fill out questionnaires. Then they'd talk about the similarities, differences, concerns and how they affected their parenting styles and decisions. One of the most timely topics involved our guest speaker who showed us some simple signs to use with Samantha. Just prior to that time, we were seeing an increase in her loud, whining sounds when she was frustrated. We were surprised how quickly Sam picked up the signs, was able to use them to help her communicate with us and as a consequence, the signing helped in alleviating her frustrations. Oftentimes, those same handouts and questionnaires became topics of discussion between my husband and I as we reflected on our parenting styles with our own children and how in our new role, we've changed in our "grandparenting style".

The well-thought out and carefully planned parent-child interaction activities provided fun, hands-on learning activities and experiences that Sammie and I could do together. After each class, we'd share with Kiana and Grant what activities we did together in class. We are especially proud of our "Sammie-&-Grammie-made" t-shirt! Through their caring, nurturing ways, Chris and Linda provided stimulating and varied activities for both adults and children. They created a safe, comfortable environment for parents to share concerns, ask questions and hear from other parents. With their knowledge and expertise, they helped to bridge families with community resources and services available to them.

Although for years, I knew that Families for Real classes were held at Kapunahala School, I never really knew what it was all about and what you did there. It is a completely comfortable and open session, and everyone is at ease to share and discuss.

The teachers our wonderful!! Chris, Linda and Julia are what ever parent wants for their child's first teachers and introduction to school. The classroom is beautiful and welcoming to the children. There are many age appropriate toys, learning centers, and books for the children to play with. And, the teachers always have a terrific organized activity for the children to do, as well as activities before class even starts.

I highly recommend the Families for Real Program to all parents I meet. The program is a major benefit to the future educational success of Hawaii's children. It could only get better by expanding the program and allowing more children to attend at more locations. To Whorn It May Concern:

I first heard about the Families for R.E.A.L program from a friend who has a toddler the same age as my son. She was so enthusiastic about her experience with the program that I immediately called and got John signed up. During the month that passed until my session began, I asked around and realized that many of my friends and acquaintances had attended one or more of the classes. They all had such positive things to say about it that my excitement level was through the roof, and my expectations were *high*.

I am happy to say that I was not disappointed. Not only were my expectations met, but Families for R.E.A.L exceeded every expectation and beyond. Being an educator myself and having taught at the elementary level for 10 years, I understand the importance of early education. When I taught firstgrade, children walked into my classroom and could not even handle a book properly. They looked at it backwards, held it up-side-down, and had absolutely no idea that the text meant something. Many did not know their letters and/or sounds, or how to properly grip a pencil. Even more did not know how to get along with others. Sharing and working together and being kind to others were foreign concepts. Others had absolutely no idea how to 'fit' within the structure of a classroom setting, finding it impossible to sit still on the carpet or in a chair, to resist the impulse to interrupt, or to follow simple directions. In summary, many of my students did not have experiences like those that my child is having in Families for R.E.A.L.

The amount of learning that takes place in a child's first five years of life is enormous. They are learning everything about their world, and are more eager to learn during this time period than they ever will be again. Not only is their *willingness* to learn at an all-time high, but their *ability* to learn is at its peak as well. They truly are sponges, soaking it all up. My son is very shy when around others in a setting outside of our home. He is also very active and has a short attention span, like most toddlers. The first three classes of Families for R.E.A.L were challenging for him. He didn't want to be too far from Mommy, he didn't want to sit in the circle for songs, he hesitantly and reluctantly interacted with the teachers and his peers. But as we attended the classes, he became more at ease and began to truly enjoy himself. He now no longer clings by my side, does not pout or cry when we enter the classroom, excitedly sits on my lap during circle time, and interacts with the teachers and his peers. It has been a learning experience that he would never have had if this program were not available. It is because of this program that my son is now more confident, a gift that this mother is overjoyed to receive.

And John is not the only one learning, growing, and benefiting from the program. As a first-time parent, I often feel insecure too. The practical conversations we parents have with the staff are extremely

helpful, and I always leave each class with a greater 'grasp' on parenting. The topics covered are always of high importance, and the open-ended feeling to our lessons leaves plenty of room for true questions and discussions. I have expressed my concerns and trials on many different occasions, making the group a great place to simply say what is on your mind without fear of judgment. I have also taken away many ideas for fun activities that I can do at home with John, and the literature that is provided is a great resource to have on hand. The time I take to truly *reflect* on my parenting and the life I am giving my son is the most valuable tool I have gained from Families for R.E.A.L. Too often we go about our days, just getting by, not really thinking about the impact everything we do as parents has on our children. This program keeps me in tune with what an awesome responsibility being a parent is, and how not to take it for granted.

I will forever treasure the experiences we have had in the Families for R.E.A.L program. I wish that every one of my students could have the opportunities that John is having in this class. When the love of learning is cultivated at a very young age, it continues into school and throughout life. Those who do not have this chance are at a great disadvantage, and this is perhaps the greatest tragedy we parents and educators must face.
