#### TESTIMONY ON S.B. 583 - RELATING TO CABLE TELEVISION SYSTEMS.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Everett Kaneshige and I am the Deputy Director of the Department of Commerce and Consumer Affairs (the "**Department**") and am testifying in support of S.B. 583.

The Department recognizes the importance of PEG access to democracy and the exchange of ideas and the opportunity for the public to share their ideas, using a media that would be otherwise cost-prohibitive for most people.

Therefore, the Department supports an exemption from HRS chapter 103 for the designation of access organizations for public, educational, and governmental (PEG) access channels as described in lines 4-10 on page 1 of the bill. The Department's position is consistent with its previous requests to the State Procurement Office in 2005 and 2006 for a similar exemption and also the recommendations of the H.C.R. 358 Task Force Report to the 25th Legislature on December 16, 2008.<sup>1</sup>

The remainder of the bill addresses the procedure to be used by the Department in conjunction with designation of the PEG access organizations. The Department points out that these procedures are already contained in section 16-131-70 of the Hawaii Administrative Rules and therefore it is not necessary to add similar provisions to HRS chapter 440G.

Furthermore, in the event this bill is enacted, HAR section 16-131-70 will need to be revised to delete the current language which requires the Department to comply with HRS chapter 103. Revisions to this section would require public hearings and will provide the Department with the opportunity to work with the PEG access organizations and our shared public, educational and governmental constituents, to develop rules which could address not only the designation of organizations but also specific terms and conditions of the agreements between the Department and the PEG access organizations.

If, however, this Committee decides to pass out this measure and include provisions on the designation procedure, the Department has concerns with the language in S.B. 583 and suggests technical amendments and clarifications be made so that the bill's provisions conform to existing statutory provisions and include proper technology. The Department would be happy to work with the Chair and her staff to come up with amendments to this measure.

Chair Baker, Vice-Chair Taniguchi, and committee members, thank you for the opportunity to testify on SB 583.

The State Procurement Office (SPO) opposes the amendment in SECTION 1 which proposes to exempt from HRS chapter 103D the designation of access organization for public, educational, or governmental access channels.

As historical background on this issue, in 2007 Maui Circuit Court ordered the Department of Commerce and Consumer Affairs (DCCA) to adopt a rule specifying method, factors and criteria used to designat e and select a PEG access organization. Subsequently DCCA initiated rulemaking process, held public hearings in Sept 2008, and HAR §16-131-70 became effective Dec. 2008. DCCA amended its Hawaii Administrative Rules (HAR) chapter 131, Subchapter 16 on *Access Organizations* for §16-131-70, *Designation and selection of access organizations* (see Attachment), that states in part, "....director shall comply with the applicable provisions of chapter 103D, HRS, when designating and selecting an access organization to oversee the developm ent, operation, supervision, management, production, or broadcasting of programs on PEG channels obtained under chapter 440G, HRS."

Another solicitation was issued on May 20, 2010 by SPO on behalf of DCCA, Cable Television Division, and is currently proceeding through the request for proposal (RFP) process. RFP-10-007-SW is for the services to *Operate, Maintain, and Manage Public, Educational, and Governmental (PEG) Access Channels, Funds, Facilities, and Equipment,* and generally contains the items listed in the proposed bill for the director to consider such as the public need for the proposed services, qualifications and financial responsibility of the applicant, etc.

Public procurement's primary objective is to give everyone equal opportunity to compete for Government contracts; to prevent favoritism, collusion or fraud in awarding of contracts. The true nature of competition gives government agencies the benefits of knowing that the acquiring of goods and services were conducted in a fair and objective manner. Meeting this objective requires a single set of statutes and rules that define and mandate the use of selection processes that are competitive, efficient, fair, transparent, open and impartial.

Statutory exemptions for specific agencies are contrary to the Hawaii Public Procurement Code, section 103D-102, HRS, on the applicability of the chapter that states in part ". . . shall apply to all procurement contracts made by governmental bodies whether the consideration for the contract is cash, revenues, realizations, receipts, or earnings, . . ." Any governmental agency with the authority to expend funds should be in compliance with chapter 103D, which promotes the policy of fair and equitable treatment of all persons who deal with the procurement system; fosters effective broad-based competition and increases public confidence in public procurement.

The SPO opposes statutorily exempting specific agencies from the Code, as it is not in the best interest of government, the business community, and the general public. The Code establishes a time-tested, fair, and reliable process for award of contracts. The competitive procurement processes of the Code are to insure that all potential providers are afforded the opportunity to compete for the required services. To the extent agencies may need specific purchases to be exempted from Code requirements, the Code provides an exemption process on a case by case basis as opposed to a total blanket statutory exemption.

The Code should not be viewed as an obstacle to a purchasing agency's mission, but rather as the single source of public procurement policy to be applied equally and uniformly. It was the legislature's intent for the Code to be a single source of public procurement policy. If individual agencies are exempted and allowed to develop their own individual processes, it becomes problematic and confusing to vendors, contractors and service providers that must comply with a variety of different processes and standards. Fairness, open competition, a level playing field, and government disclosure and transparency in the procurement and contracting process are vital to good government. For this to be accomplished, we must participate in the process with one set of statutes and rules. To legislate that any one entity should be exempt from compliance with the procurement code conveys a sense of disproportionate equality in the law's application.

If the Legislature intends to exempt specific programs or funds from the Code, the exemption should include assurances that the agency's exempt process includes fair and open competition, disclosure, transparency, due process for aggrieved parties, a defined selection and awards process, and the various elements contained in the Code to ensure public confidence that the exempt procurement process is as fair as the Code.

There is no compelling reason to exempt the procurement of contracts to manage and operate PEG access channels, funds, facilities and equipment from fair and open competition. We request that SECTION 1 be deleted. Thank you.



Aloha Chair Baker, Vice Chair Taniguchi and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative working on prison reform and justice issues in Hawai'i for more than a decade. We respectfully offer our testimony always being mindful that Hawai'i has some 6,000 people behind bars with almost 1,800 individuals serving their sentences abroad, thousands of miles away from their loved ones and homes – the ancestral homes for a disproportionate Native Hawaiians.

I am also the producer and host of *Hawai`i InJustice*, an 'Olelo community television show that airs the first Tuesday of every month at 8:30 pm and every Thursday morning at 8 am on Channel 54.

SB 583 allows the Director of Commerce and Consumer Affairs (DCCA) to designate an access organization to oversee public, educational and governmental channels on cable television.

Community Alliance on Prisons stands in strong support of this measure that preserves the community voice and clarifies Chapter 440G, outlining the criteria the Director must consider before letting a contract from PEG access.

This is important because the community voice is part of the Director's criteria for selection. This is especially vital in challenging economic times. We the people must always be vigilant that the government doesn't corporatize public assets. These assets are known as The Commons.

PEG (Public, Education, Government) access is a vital part of a thriving democracy. It provides access to information that is, in some cases available nowhere else. Access to current information is even more important for Hawai'i, as many of our communities are separated by ocean. Access to technology facilitating information to connect our islands is not yesterday's luxury – it is today's necessity.

This bill ensures that the public has a voice in keeping public access, well, public! Public access (and we mean PEG access) is

- a public right
- democracy in action
- a way to create a more informed citizenry
- a way to build strong, involved, and committed communities

a window for policymakers to see, hear and understand issues important to their constituents

When we say public access is a public right, we mean just that. This is the rent - and it is indeed low rent considering the corporate benefit cable television operators gain from the use of public-rights-of-way - for the use of public space.

#### A vibrant democracy demands participation

Many people feel left out of the mainstream media. The community's voice is often relegated to a 30 second sound bite, if anything at all.

Public access/community media provides a venue for the discussion of issues important to the community. This education encourages participation in the democratic process.

#### Public access/Community media is vital in Hawai'i because we are a multi-cultural society

We have many immigrants who come to Hawai'i and desperately want to connect with what is going on, but find it very difficult to determine how to do this. Mainstream media do not do much to help people fit in.

#### Freedom of speech is a vital component of democracy

The Constitution has been under siege, and one of the most important freedoms enshrined in the Bill of Rights is freedom of speech. Public Access/community media provides an uncensored venue for our community to learn about issues, to find ways to participate in their communities, and to be more active contributors in shaping Hawai`i's future. Public access promotes the first amendment!

#### Community media increases civic literacy

Hawai'i has pitiful voting numbers. We rank at the bottom for voter participation. It is obvious from our dismal voting numbers that people feel disenfranchised and separated from the government. Yet we are the government. Public access/community media brings issues to the people and calls for their participation. In election cycles, the community can tune in and hear from candidates running for office. This creates a more engaged and educated voter.

Keep Public Access PUBLIC! We support this measure that ensures the public will have a voice in the PEG process that is made clearer with the amendment to Chapter 440G.

A vibrant democracy demands an involved citizenry and every effort to educate and involve the citizens on important issues should be wholeheartedly supported by our government.

My name is Roy Amemiya, Chief Operating Officer and Interim President/CEO of 'Ōlelo Community Media, the PEG Access Provider for Oahu. 1 am writing to strongly support SB 583 Relating to Cable Television Systems. This bill would change the State's procurement process of PEG Access service providers by designating a new process within HRS 440G that is modeled after the process used to procure cable franchises.

The genesis of this measure actually began in 2008 with the unanimous House and Senate enactment of HCR 358, HD1 which established a task force to "solicit public input and examine methods other than public procurement code process to oversee PEG organization expenditures and ensure proper checks and balances". The resolution text is also clear that this body felt that procuring PEG access using HRS 103D has many shortcomings and that another method should be explored by the task force.

Members of the 12 person task force consisted of representatives from the DOE, the UH, the cable advisory committee, all four county governments, all four PEGs, and the state cable administrator. I served on the task force and was an 'Ölelo board member at the time.

The task force met a total of 7 times and debated multiple procurement options. These meetings were open to the public and testimony was received from members of the community at each meeting. In the end, all task force members agreed on the option that is recommended in the HCR 358 Task Force Report to the 25<sup>th</sup> Legislature and is proposed in this bill. Briefly described, the concept is to take the existing process for both new and renewing cable franchise applicants and apply a similar process to PEG access providers. That process, among other things, requires that a public hearing be conducted on the application. In that way, it is much more transparent than the current RFP process. It also allows the DCCA to get an understanding of the needs of the community. This, I believe would be very beneficial in crafting concrete contract

I helped draft the language in this bill which was originally offered in Senate Bill 1789 during the Twenty Fourth Legislature of the State of Hawai'i then, in similar form as Senate Bill 2387 during the Twenty Fifth Legislature of the State of Hawai'i.

This bill helps resolve some of the consequences of the unusual policy decisions made in the last five years by the Department of Commerce and Consumer Affairs regarding cable access and access organizations.

The bill does not address the dearth of appropriate regulatory oversight of cable access and leaves too much of the important public policy decision-making regarding cable access to state educational departments, incumbent access organizations and the county governments.

For example, the important policy considerations related to the diversion of franchise fees to the University of Hawai'i and the Department of Education should not be left to the outcome of the unequal bargaining between those state departments and the incumbent access organizations.

Nevertheless, the bill creates a level of stability and clear procedure for the director to exercise her discretion in designating access organizations and may help resolve some of these other issues.

My name is Linda Ruth Puppolo. I am a resident of Maui County and I offer my testimony in strong support of SB583.

The first point of this bill is that it allows for the Director of the DCCA to have the power to designate PEG access providers in Hawaii and oversee the development, operations, management, production & broadcasting of the service exempting providers from 103D (basically procurement of the lowest bidder).

The knowledge gained from eighteen years of the development of strategic nonprofit & County Government partnerships, ensuring the availability of video equipment and experience in training the community in video literacy is the cornerstone of Akaku's (Maui County's PEG Access provider) commitment to the community. This knowledge and the social capital that has been realized over the years are irreplaceable.

In serving as a communication network with a vision to promote free speech and expression through access to communications technology, resources and training, Akaku facilitates the dissemination of information that is relevant to the community with an emphasis in preserving the host culture's traditions, rights and practices to enable the culture to be archived for the benefit of the residents of Maui County.

Akaku has recently been awarded a Federal \$132,000 Broadband Technology Opportunity Program (BTOP) Grant to service the rural communities in Maui County. This 2 ½ year grant gives opportunity to youth and young adults to learn, master and possibly create careers in the field of technology. Despite the five years of instability created by the RFP process that the state has tried to impose, Akaku has continually rallied by producing cutting-edge programs that have raised the level of PEG access services. This bill would provide the stability that PEG needs to grow and expand.

While the bill is intended to provide strong accountability and performance standards, it is important to note that each PEG Access Media Center in Hawaii provides the state with a comprehensive independent audit and comprehensive operational plan & annual report each year always exhibiting a level of strong accountability and high performance standards.

It is also important to note that there have been no complaints about Akaku services from the residents of Maui County and that when the DCCA conducted a site visit for potential bidders for the RFP; only the DCCA attended. The previous meeting the DCCA conducted had over 150 people in attendance to discuss rule changes with 75 people testifying in support of Akaku services and one person opposed. It is pretty clear that the residents of Maui County value and want Akaku

to be the service provider of PEG Access Services. Please pass SB583 and help us stabilize the economic base of an excellent nonprofit during these times of dwindling donations and competitive grant funding. An RFP would disrupt an essential service that is performing well.

#### TESTIMONY

Thank you for this opportunity to speak in support of Senate Bill 583. This bill will formally end the debate over whether DCCA must follow the procurement process in selecting PEG Access providers. While the state procurement process is an important part of the way the state acquires services from a wide variety of vendors, PEG Access is literally the round peg that does not fit into the procurement code's square hole. PEG Access – and especially the Public or "P" element of the equation -- is a unique service, providing a free speech channel that serves our democracy. Trying to "procure" it, in the same manner that we procure a bus service for school transportation or a roofing job on a building, simply will not serve the best interests of our community.

I am a former Member of the State Cable Advisory Council. As such I took the opportunity to thoroughly review the first draft of the proposed Request for Proposals put out by the state Procurement Office. The impression given is a process that leaves the PEG agencies little room to grow or even to have a clear identity of what they are. While it is always valuable to question how we do business, we should not lose sight of the fact that these agencies grew out of their host communities, with much nurturing and aloha. They are not for-profit agencies, and for better or worse, they provide an independent voice – an increasingly important voice –and by doing so, they meet their intended purpose. They are not governmental agencies and should not be forced into that role. But the RFP seemed to make them out to be oddly subordinate governmental agencies, even requiring them to follow Chapter 92 while ignoring the First Amendment implications of this service. The RFP declared that the State shall own all PEG property and assets, and leaves the PEGs with no sense of ownership or any incentive to grow their agencies to better serve our community. That's not a recipe for building a strong PEG system.

SB 583 puts the Director of Commerce and Consumer Protection in charge of making sure the proper agency is selected and is given appropriate oversight. That's what our community would like to see happen and an approach that I support. Mahalo.

I'm interested in Bill No. 583 from the following perspectives:

--Although I wouldn't presume to call myself "unique," I do have some elements of my background and current situation that I believe are pertinent here:

----I'm an 'Olelo viewer, a regular consumer of the varied and valuable programs offered by the public-access TV medium.

----I'm a trained 'Olelo cameraperson, editor and producer. I've (together with two co-producers) aired hundreds of programs on 'Olelo – typically on Channels 49 and 54 – since late 2005, or five-plus years.

My experience with 'Olelo executive, administrative, and technical people has always been one of satisfaction. It is my distinct pleasure to interact with a staff that has a big-picture sense of what public-access TV is and how it should best be pursued in making free speech and expression a daily part of life in our community.

----I'm a retired Federal civil servant whose career, starting in 1968, was in the procurement and contracting field. I retired in 1999, so I had some 30 years of procurement experience.

For five years or so now, I've observed, and participated in, the long-term discussions over whether a new procurement contract for operation of public-access TV services should be undertaken, through competitive RFP (Request for Proposals) procedures. My position has been fairly simple and straightforward: whereas,

in the Federal sector, people like me were responsible for expending the taxpayers' money properly through stringent contracting rules and procedures – typically, *via* price and/or technical competition – the services provided by 'Olelo for over 20 years do not fit that category. (I note in passing that, in 1984, the concept

of "competition" was enshrined in Federal law via the Competition in Contracting Act, or CICA. CICA became

the "go to" statute governing every procurement, and as far as I know it is still given at least lip service,

despite misadventures some of us may have read about in Iraq, Afghanistan and elsewhere.) My cable franchise fee, and the fees of others, which are allocated in part to make public-access TV a reality on 'Oahu and on the neighbor islands, are not "taxpayer" dollars – and thus the common competitive environment

via a procurement channel does not pertain.

It is thus my firm belief that Senate Bill 583, which would delegate responsibility to secure and oversee

the operations and management of a public-access TV provider to the competent technical folks at DCCA,

is the needed step in the right direction.
