- 1 Department's Position: The Department of Health respectfully submits the following information on
- 2 this measure. The City and County of Honolulu is making progress in upgrading the Wahiawa
- 3 Wastewater Treatment Plant (WWTP) to produce effluent of R-1 quality. From a public health
- 4 standpoint, R-1 water can be used on any form of irrigation of food crops, including all edible root crops
- 5 and where the recycled water comes in contact with the edible portion of the crop. It will not limit the
- 6 production of diversified agriculture on the north shore. Other areas of R-1 water usage include: golf
- 7 courses, parks, playgrounds, school yards, and pasture land. The R-1 quality discharge will improve the
- 8 quality of the water in Lake Wilson.
- 9 Fiscal Implications: Authorization of \$300,000 of general funds is needed to carry out the work of the
- 10 task force.
- Purpose and Justification: This bill authorizes the formation of a task force under the Department of
- Land and Natural Resources. A major objective of the task force is to assess the current condition of the
- waters of Lake Wilson and to make recommendations to improve the quality of the water in the lake to
- 14 acceptable levels.

- 1 Lake Wilson currently receives R-2 water quality effluent from the Wahiawa WWTP. The discharge of
- 2 R-2 effluent from the Wahiawa WWTP limits agricultural production due to restrictions placed on R-2
- 3 water usage. The legislature is concerned about the progress of the City and County of Honolulu to
- 4 upgrade the Wahiawa WWTP to produce R-1 water. However, the City recently issued a notice to
- 5 proceed to its contractor to construct the final phase of the Wahiawa WWTP upgrade work to enable the
- 6 plant to produce R-1 quality water. The work is expected to be completed by July 2012. We suggest the
- 7 creation of the task force be delayed until after construction is completed to assess the quality of the
- 8 lake.
