1 Department's Position: The Department of Health opposes S.B. 708 which would amend Chapter

2 328J, Hawaii Revised Statutes, to allow smoking in establishments and on premises that hold certain

3 classes of liquor licenses, requires the Department of Taxation to issue smoking establishment permits,

4 requires holders to post specified signs, preempts counties from superseding state law, and make

5 conforming amendments.

6 **Fiscal Implications:** Potential revenue to general fund from permit fees. Defer to the Department of

7 Taxation for any calculation of potential revenue gain.

8 Purpose and Justification: This bill would amend Chapter 328J, Hawaii Revised Statutes, by

9 allowing smoking in establishments with certain classes of liquor licenses, thus eroding protections

against the involuntary exposure to tobacco smoke. It would also create a preemption for counties that

11 would prohibit them from passing county ordinances that supersede state law. This bill would reverse

12 years of 'home rule' precedent where counties could act to protect their citizens. The bill would also

13 effectively remove the equal protections that have been provided under the current statute to protect all

workers and patrons in all enclosed and partially enclosed workplaces against secondhand smoke, a
 known and proven carcinogen.

The clear purpose of the 2006 legislation was to create equal protections for all employees, in every sector of the economy, across the state. For the vast majority of the businesses which have complied with the law, these protections are working. There is appropriate signage, employees and customers know that smoking is not permitted and are complying, and there are designated smoking areas beyond the twenty foot perimeter from doorways and windows. As a result of the law, businesses have encouraged workers who smoke to consider quitting, and there have been increases in calls to the Hawaii Tobacco Quitline.

From a public health perspective, to now create an exemption for certain classes of liquor licenses would be to disregard the public health findings from the US Surgeon General's reports from 2006 and 2010 detailing the risks and harm from exposure to tobacco smoke. This measure goes against the Legislature's intent in the 2006 law to provide for a workplace free from exposure to tobacco smoke where an employee does not have to choose between a paycheck and their health.

This bill does not represent a forward step in improving the health for Hawaii's workers and
 would effectively place more employees and customers at risk for tobacco related illnesses.

This measure, among other things, requires the Department of Taxation (Department) to issue "smoking establishment permits" to businesses that hold certain classes of liquor licenses.

The Department opposes this measure due to the impact upon the Department.

THE DEPARTMENT WILL EXPEND CONSIDERABLE RESOURCES—Because a permit can only be issued to businesses that meet the requirements of this measure and such rules as are adopted by the Department of Health, the Department will expend considerable resources training personnel in identifying eligible businesses and the acceptable classes of liquor licenses. This will divert the already strained resources of the Department away from its core mission of collecting taxes and insuring compliance with the tax law.

THE DEPARTMENT OF TAXATION SHOULD NOT REGULATE HEALTH CONCERNS—The Department points out that it is not the experts in regulating health issues. For example, this measure does not amend tax law. It amends health laws. As such, the Department opposes being charged with administering health related permits as contemplated by this bill.

Testimony in strong OPPOSITION to SB 708

The American Heart Association strongly opposes SB 708. There can be no compromise when it comes to protecting the health of Hawaii's workers, or its public.

Heart disease is the leading cause of death in the United States, according to the Centers for Disease Control and Prevention (CDC). An American has a coronary event (heart attack) nearly every 25 seconds, resulting in death about every minute. Smoking is the leading risk factor for heart disease.

Evidence suggests that exposure to secondhand smoke also can result in adverse health effects, including heart disease in nonsmoking adults. Secondhand smoke, also known as environmental tobacco smoke, consists of a mixture of gases and particles including smoke from burning cigarettes, cigars, pipe tobacco, and exhaled mainstream smoke. Smoking bans are making progress at reducing involuntary exposure to secondhand smoke in workplaces, restaurants, and other public places in the United States and abroad. Such legislation has also provided the opportunity to study the effects of smoking bans on the health of smoking and nonsmoking adults.

Cardiovascular disease is a major public health concern. Study results consistently indicate that exposure to secondhand smoke increases the risk of coronary heart disease by 25 to 30 percent.

Furthermore, exposure to tobacco smoke – even occasional smoking or secondhand smoke – causes immediate damage to your body that can lead to serious illness or death, according to a report released in 2010 by U.S. Surgeon General Regina M. Benjamin. The comprehensive scientific report - Benjamin's first Surgeon General's report and the 30th tobacco-related Surgeon General's report issued since 1964 - describes specific pathways by which tobacco smoke damages the human body and leads to disease and death.

The report, *How Tobacco Smoke Causes Disease: The Biology and Behavioral Basis for Smoking-Attributable Disease,* finds that cellular damage and tissue inflammation from tobacco smoke are immediate, and that repeated exposure weakens the body's ability to heal the damage. Even brief exposure to secondhand smoke can cause cardiovascular disease and could trigger acute cardiac events, such as heart attack. The report describes how chemicals from tobacco smoke quickly damage blood vessels and make blood more likely to clot. The evidence in this report shows how smoking causes cardiovascular disease and increases risks for heart attack, stroke, and aortic aneurysm.

Given the prevalence of heart attacks, and the resultant deaths, smoking restriction laws save thousands of lives each year in the U.S. alone. The savings, as measured in human lives, is undeniable.

Alternatively, the costs of not restricting smoking in workplaces are equally staggering. According to the American Heart Association's 2010 Statistical Update, the total direct and indirect cost of CVD and stroke in the United States for 2007 is estimated to be \$286 billion.. The CDC estimates that smoking is responsible for direct medical costs of \$96 billion and

"Building healthier lives, free of cardiovascular diseases and stroke." lost productivity costs of \$97 billion, or a total estimated \$193 billion per year. Some estimates have put the annual costs of excess medical care, mortality and morbidity caused by second-hand smoke alone at more than \$10 billion.

The American Heart Association strongly urges Hawaii legislators to support the existing law which has proven to be a success from both a health and a business standpoint, and to fulfill their pledge to uphold the State Constitution in which Article IX, Section 1 states, "The State shall provide for the protection and promotion of the public health." Please oppose SB708.

The Coalition for a Tobacco-Free Hawaii strongly opposes SB 708 Relating to Smoking. We ask that you hold it in Committee.

The Coalition for a Tobacco-Free Hawaii (Coalition) is the only independent organization in Hawai'i whose sole mission is to reduce tobacco use through education, policy and advocacy. Our organization is a nonprofit organization of over 3,000 organizations and members working to create a healthy Hawaii through comprehensive tobacco prevention and control efforts. In 2006, the Coalition and its partners worked to pass the Smoke-Free Workplaces Law—HRS 328J. Hawaii became the 14th state to adopt a comprehensive statewide law to address dangerous secondhand smoke exposure in workplaces. This law ensures that workers and patrons are free of secondhand smoke in enclosed and partially-enclosed areas open to the public.

The measure before you today will undermine some of the protections guaranteed to workers and those who patronize businesses—the right to breathe air free of tobacco smoke. This measure will allow bar owners to purchase a "smoking establishment permit" from the Department of Taxation to allow smoking in their bar. This is a step in the wrong direction. Eroding our strong Smoke-Free Workplaces Law opens the door to more businesses seeking exemptions from the Smoke-Free Workplaces Law. This measure also creates an unequal playing field for bars, allowing a minority to profit at the expense of the public health. **Our public deserves the right** to smoke-free air. And, it is the role and responsibility of lawmakers to regulate business when the health and safety of the public is concerned.

I. The Smoke-Free Workplaces Law Is Necessary for Workers and the Public's Health

The measure provides no protections for workers. Workers employed in a bar that elects to purchase a smoking establishment permit will be exposed to secondhand smoke and the numerous risks associated with it—for some, the health threats are so serious that they will be

forced to quit or worse suffer with life-threatening harms to earn their wage. The only way to protect workers and patrons from involuntary secondhand smoke exposure is to prohibit smoking in enclosed and partially enclosed areas as we have now.

II. Secondhand Smoke is a Serious Health Threat and Can be Lethal

Secondhand smoke is dangerous; the U.S. Surgeon General in 2010 notes that any level of exposure to secondhand smoke is dangerous and can be harmful. The International Agency for Research on Cancer and the U.S. Environmental Protection Agency both note that environmental tobacco smoke (or second-hand smoke) is carcinogenic to humans. Secondhand smoke contains 7,000 identifiable chemicals, 69 of which are known or probable carcinogens. And, The World Health Organization states that "[s]cientific evidence has firmly established that there is no safe level of exposure to second-hand tobacco smoke (SHS), a pollutant that causes serious illness in adults and children. There is also indisputable evidence that implementing 100% smoke-free environments is the only effective way to protect the population from the harmful effects of exposure to SHS."¹

Secondhand smoke, or involuntary or passive smoking, is a known cause of lung cancer, heart disease, low birth-weight births, and chronic lung ailments. The CDC notes that 50,000 Americans die each year from lung cancer and heart disease attributable to secondhand smoke exposure.² The Institute of Medicine ("IOM") most recently reported in "Secondhand Smoke Exposure and Cardiovascular Effects: Making Sense of the Evidence" on conclusive evidence that secondhand smoke causes heart disease, including heart attacks. The IOM committee of scientific experts concluded "there is a causal relationship between smoking bans and decreases in acute coronary events" and "the evidence reviewed by the committee is consistent with a causal relationship between second-hand smoke exposure and acute coronary events, such as acute MI (myocardial infarction)."

III. Neighboring Businesses and Their Workers and Patrons Would Also Be Exposed to and Not Protected from Secondhand Tobacco Smoke

There is no ventilation system that will keep workers safe from second-hand smoke exposure and remove all of the toxins and particles found in secondhand smoke. In 2006, the US Surgeon General in "The Health Consequences of Involuntary Exposure to Tobacco Smoke" concluded that ventilating buildings, or trying to separate smokers from nonsmokers cannot eliminate secondhand smoke exposure. This measure does not only impact bars and the workers in those bars. If passed, the measure will impact other businesses that neighbor bars who acquire "smoking establishment permits", and those who work and patronize those businesses.

IV. Smoke-Free Workplaces Laws Do Not Harm Businesses

One year after Hawaii's Smoke-Free Law went into effect, it was found "there is no evidence to suggest that the Hawaii Smokefree Law has harmed the hospitality or tourism industries as a whole"³ according to the Roswell Park Cancer Institute. Additionally, the Surgeon General reported that "[e]vidence from peer-reviewed studies shows that smoke-free policies and regulations do not have an adverse economic impact on the hospitality industry."⁴

V. Support for the Smoke-Free Workplaces Law Has Grown Since the Law Went into Effect

In 2007, 82 percent of Hawaii residents supported the law. In 2008, that number grew to 85% a majority of Hawaii's residents. Additionally, Hawaii residents care about the health of workers. In 2007, 77% of Hawaii residents strongly agreed that all workers in Hawaii should be protected from exposure to secondhand smoke in the workplace. In 2008, that number increased to 82% of a majority of residents supporting protections for workers.

The Legislature must maintain our Smoke-Free Workplaces law. It is effective public health policy. It is fair and equal to all business owners. It protects worker and the public. It improves our health and saves lives. Please remain committed to the health of our workers and the public. We ask that you hold this measure in Committee. Thank you for the opportunity to comment on this matter.

I am a volunteer for the American Cancer Society here on Maui, and submit this testimony in strong opposition to Senate Bill 708, "A Bill For An Act Relating To Smoking". This proposed bill would allow places where we work and public areas that we go to, to be smoke filled.

It was a tremendous step forward to prohibit smoking in our work areas and public areas. As employees and members of the public, we should not have to be subjected to secondhand smoke which places our health at serious risk—whether it be at work or going out to a restaurant. Permitting bars and night clubs to allow smoking is a great step backwards. We should be able to be at work and go to public places without being subjected to the risks of a smoke filled environment.

Smoking and second hand smoke puts our health at risk and is known to cause not only lung cancer, but many different kinds of cancer (i.e. breast, oral cavity, pharynx, larynx, esophagus, bladder, stomach, cervix, kidney and pancreas, and acute myeloid leukemia). The Center For Disease Control estimates that 46,000 deaths a year are related to second hand smoke.

Smoke-free laws such as what Hawaii currently has, continue to be passed. There are now 39 smoke-free states and Hawaii was the 14th state pass a smoke-free law. I have seen that having a smoke-free law has

positive impacts on myself, family, and friends. The smoke-free law is working and should not be rolled back

Re: Strong Opposition to SB 708.

I support the 2006 Smoke-Free Workplace law as is. The current law protects all workers from exposure to secondhand smoke.

I oppose SB 708 as it would erode the law and place employees at risk for exposure to secondhand smoke, as well as those of innocent patrons. Exposure to tobacco smoke – even occasional smoking or secondhand smoke – causes immediate damage to your body that can lead to serious illness or death, according to a report released by U.S. Surgeon General Regina M. Benjamin.

Hawaii's smoke-free law has been one of the best pieces of public health legislation our Legislature passed. Because of it, I now work in a place that is smoke free. Our workers and the public should not be exposed to secondhand smoke which leads to serious health risks and forces many to risk their health to earn a living.

Allowing bars and night clubs to permit smoking again would be taking a very huge step backwards.

We must keep Hawaii's Smoke-Free Law strong. It has been over 5 years since law passed. The law is working! It is saving lives and creating a cleaner, healthier work and public environment.

Dear Honorable Committees,

I support bars that have experienced economic hardship to be able to be exempt from the ban. I support this bill for several reasons.

- 1.) The ban has caused significant hardship to a number of bars in the community to the point were they have to let people break the law. The Honolulu liquor commission's own sales numbers showed that the industry lost millions of dollars in sales after the ban. Before the ban it had experienced steady growth of 5% per year from 2003 to 2006. If we recall bars owners joined together to file a lawsuit against the state for loss of business. Furthermore our research has shown that the ban has affected bars unevenly, with some taking far greater losses than others, based on who their cliental was. This was further backed up by former Honolulu Liquor Administrator Dewey Kim who reported to the Small Business Regulator Review Board that certain segments of the bar industry were "really hurting" from the ban.
- 2.) Enforcement of the ban will be costly, problematic, and cruel. We have only to look to other states to see the results. In Ohio for example the Health department levied \$33,100 in fines against Zeno's bar in Franklin county. Zeno's, put in a clearly disparate situation between giving the majority of their customers what they want and the ban, the *1851 Center for Constitutional Law*, took up Zeno's case pro-bono.

The court found that the Health Department had acted improperly for fining the bar and refusing to fine the smokers themselves. The case is now in a costly series of appeals.

Furthermore, the media attention the case generated exposed that bar smoking bans are difficult and costly to enforce. It was exposed that the taxpayers in the end had to foot the costs of enforcing a sumptuary law against consenting adults quietly enjoying themselves on private property.

As of Feb 2010 Cost to enforce the Ohio ban = \$2,400,000 Total fines levied (\$100-\$2,500) = \$1,100,000Total fines successfully collected = \$ 473,000 Total net loss to taxpayers = -\$1.927.000 Total net loss assuming all fines can be collected without any additional enforcement or court costs to the state. = -\$1,300,000

However SB708 is a revenue generator that can successfully remove most of the need for costly and draconic enforcement while at the same time putting badly needed monies in the general fund via the sale of permits that make sure proper signage is posted.

3.) As for the "second hand smoke" argument, it is dubious at best. The first large study that the anti-smoking lobby pushed though was a metaanalysis known as the "1993 EPA" study claiming that environmental tobacco smoke was killing 3000 people a year. The study was taken to federal court and found to be a biased and unscientific fraud. That the EPA had withheld data, had a biased pre-determined outcome, redid the study when they didn't get the results they wanted, had cherry picked data, and other wise abused meta-analysis. Meta-analysis itself is highly vulnerable to something called "selection bias". Selection bias is when unfavorable data or studies are ignored. The EPA eventually appealed this ruling only on lack of regulatory weight (no one had gotten fined due to their sham study). The anti-smoking lobby still proudly uses the study as gospel to this day.

Some years later the World Health Organization did a large study on environmental smoke and cancer. In this study they found one group that was exposed to environmental tobacco smoke to have LESS of a cancer incidence and the other to have a small increase. However this small increase was not statistically significant, in other words the sample group was too small and the margin for error to large. Nevertheless the WHO shamelessly did science by press conference (a danger sign of junk science) claiming a clear link between environmental tobacco smoke and cancer. Never mind that their own numbers did not statistically reflect that!

4.) Finally, the public is in support for an exemption for bars. This would be especially true in the case of hardship. While the anti-smoking lobby claims high levels of support for the ban, keep in mind that this is based on a highly loaded question from a telephone poll. Basically if you say no to the ban in bars based on their question, by default you have to say yes to smoking in family restaurants, offices, banks, retail shops, and even day care centers and hospitals. Few people would say yes to all of these places together.

However, when Gallop polls asks the question in a way reflecting the intent of SB708, you get a far different response.

Gallop polls did the poll three times between 2005 and 2010 and consistently found support for a total smoking ban inside of bars to be only 29-31%.

Support for a total ban inside of restaurants during that time frame was between 54 and 59%. SB708 does not exempt restaurants.

5.) Finally this article in the Honolulu Weekly shows why bars are letting people break the law, not because they are "scofflaws", but because of the hard reality.

'The place was like a morgue,' says Cliff, who agreed to talk to us on condition of anonymity. The reason: he allows his customers to routinely break the law. The bar's owner also requested that his establishment remain nameless for the same reason.

...He claims his business dropped by at least 75 percent. 'After that, I begged the owner to let my customers smoke,' he says. 'I even offered to pay for any fine we might get out of my own pocket.'

Eventually the owner capitulated. Cliff brought the ashtrays out for the first time in February. 'It wasn't an immediate change,' he says, 'but it did start picking up. After two weeks I was upnot back up to original levels-but I was the first person to break one thousand [dollars] in the till since the ban passed.'

It wasn't long before other bartenders followed his example."

I ask you to please pass SB708 to support the civil liberties of consenting adults on private property, do what is economically sound, and support the majority will of you constituents.
