TESTIMONY ON SENATE BILL NO. 775 RELATING TO CONSTRUCTION SITES

The Department of Commerce and Consumer Affairs ("Department")

appreciates the opportunity to testify on Senate Bill No. 775, Relating To

Construction Sites. My name is Jo Ann Uchida of the Department's Regulated

Industries Complaints Office ("RICO"). RICO offers the following comments on the bill.

Senate Bill No. 775 extends the Construction Site Inspection Task Force ("CSITF"), created by Act 121, Session Laws of Hawaii 2010, for one year, requires a final CSITF report, and appropriates monies to fund the work of the CSITF.

The Department, pursuant to Act 121, convened the CSITF last year. The Act had an effective date of July 1, 2010, and required a report to be submitted to the Legislature no later than 60 days prior to the 2011 regular session. The report was submitted to the legislature on November 24, 2010. A copy of the report is available electronically at http://hawaii.gov/dcca/reports/dcca reports.

The CSITF convened four times over a five-month period. Also, because many of the issues relating to the CSITF dealt with law enforcement matters, a permitted interaction group was created in accordance with Haw. Rev. Stat. 92-2.5.

Pursuant to Act 121, the CSITF was comprised of representatives from the Department of Commerce and Consumer Affairs, Department of the Attorney General, Department of Labor and Industrial Relations' Disability Compensation Division, Department of Labor and Industrial Relations' Occupational Safety and Health Division, Department of Labor and Industrial Relations' Unemployment Insurance Division, Department of Taxation, County of Maui Public Works Department, and City and County of Honolulu Department of Planning and

Permitting. The County of Maui covered the travel costs associated with the participation of its representative in the CSITF meetings. Other neighbor island counties may have been willing to attend CSITF meetings, but expressed concerns about the travel costs.

The report discussed the work of the California Economic and Employment Enforcement Coalition (EEEC), the California Contractor's Board, as well as the work of the CSITF participant agencies, discussed the extent to which regulatory partnerships are used in California and how they would work in Hawaii, and contained nine (9) findings and ten (10) recommendations. In addition, as part of its annual training, RICO invited CSITF agencies and their enforcement staff to participate in a joint, one-day cross training session to familiarize staff with the work of the various enforcement agencies.

CSITF members now have a shared contact list that has already proved useful in a recent case involving an unlicensed contractor who has a large outstanding tax obligation.

The CSITF has completed its review and submitted its recommendations.

The Department intends to implement, to the extent possible, some of the CSITF recommendations. As such, the Department does not believe that the use of additional government time and resources to continue the CSITF is warranted at this time. If the Committees are inclined to continue the CSITF, the Department suggests that the Committees consider reformulating the composition and objectives of the CSITF in a manner consistent with the CSITF's findings.

We are in support of this bill.

The purpose of the Construction Site Task Force was to look at the unlicensed contractor situation and have further discussion in order to determine the feasibility and appropriateness of additional efforts. Unfortunately, the interim report is rather disappointing to the extent that perhaps there was a fault in the task force in that it lacks industry representation in order to better communicate the extent of the problem, the nature of the problem and the importance of the problem. Therefore, while we do support this bill we would also suggest an amendment to the composition of the Construction Task Force adding a minimum of three (3) additional members, all to be from members of the construction industry or their representatives.

Based on the above, we highly recommend the continuance of this Task Force as it delves into this historical and long standing problem.
