In order to encourage open and voluntary participation by provider organizations represented by HAH members, it is necessary that HAH's Patient Safety and Quality Committee have similar protections as those committees formed by hospitals, health maintenance organizations and statewide trauma care systems.

My name is Gordon Ito, State Insurance Commissioner, testifying on behalf of the Department of Commerce and Consumer Affairs ("Department"). The Department takes no position on this bill which creates a mandated benefit requiring policies of accident and health or sickness insurance to provide coverage for palliative care. Mandated benefits help some people, but impose costs on other people. We believe this trade off is best left to the wisdom of the Legislature, following the review by the Legislative Auditor required under HRS section 23-51.

Honorable Chairs and members of the Senate Health Committee, I am Walter Yoshimitsu, representing the Hawaii Catholic Conference. The Hawaii Catholic Conference is the public policy voice for the Roman Catholic Church in the State of Hawaii, which under the leadership of Bishop Larry Silva, represents over 200,000 Catholics in Hawaii.

The Hawaii Catholic Conference strongly supports increasing public access to the life-affirming services of hospice and effective palliative care. While we leave to the bills' sponsors the technical explanations as to why this bill is needed, we would like to provide this committee with three reasons why hospice and palliative care must be at the forefront of our State's health care policy agenda.

First, hospice and palliative care respond effectively and compassionately to the very real needs of the seriously ill. They do so in a manner that affirms the value of the lives at stake, unlike proposals to legalize assisted suicide, which treat the dying as burdensome candidates for killing rather than as fellow human beings deserving of our care.

Second, hospice and palliative care are the preferred means for addressing the needs of persons living with terminal conditions and of their caregivers. Opinion surveys show that when asked, members of the public agree that hospice and palliative care should take priority as the best approaches to accomplishing good end of life care.

Third, improving access to hospice and palliative care has become a goal around which substantial organizational consensus is forming in Hawaii. We have a unique opportunity to put our efforts into better care at the end of life.

### Supporting the intent of SB 941.

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including all acute care hospitals, as well as long term care facilities, home care agencies, and hospices. Thank you for this opportunity to testify in support of the intent of SB 941, which requires health plans to provide coverage for palliative care.

The Healthcare Association fully recognizes the benefits of palliative care and encourages its expansion throughout the state. In recent years, insurers, providers, and palliative care advocates such as St. Francis Health Systems and Kokua Mau have been working together to improve access to palliative care. Today, palliative care is available in many more health care settings, and there is much more insurance coverage for it.

It is estimated that hospice usage has doubled in 10 years, and today nearly one-third of all people who die have received hospice care before their deaths. The John A. Burns School of Medicine now requires its students to take a course in palliative care, and student nurses routinely do community rotations through hospice providers.

The Healthcare Association supports the continued collaboration to expand palliative care. However, we feel that a law that mandates insurance coverage is not needed at this time. Rather than a mandate, we would suggest a resolution that recognizes progress that has been made in recent years and encourages continued collaboration and the continued expansion of palliative care.
