We strive to ensure a nurturing, safe and healthy development for all children from pre-birth to age eight. We believe all children deserve safe and supportive environments that meet their needs as they grow and develop. Good Beginnings is also a member of One Voice for Hawaii's Children (www.onevoiceforchildren.net), an alliance of organizations and individuals committed to the development of an effective and equitably funded early childhood system that gives all young children the opportunity to arrive at kindergarten safe, healthy and ready to succeed. The following information is provided to help you in your decision-making process.

The Early Learning Council was established by Act 14, Special Session 2008, to develop and administer the early learning system for Hawaii. For the council to produce the full system plan, it will need operational funding for each of the next two fiscal years. They are comprised of volunteers with no full time staff to accomplish the critical development the state's early learning system to benefit all children throughout Hawaii, from birth until the time they enter kindergarten.

We know that the Council is also working on a long-term and fiscally responsible plan to launch such a system. The fiscal mapping study to include the identification and development of a direct funding stream of the system mentioned in this bill is in accordance with this task. Moreover, indications are that the Governor will soon designate the Early Learning Council as the State Advisory Council on Early Childhood Care and Education as mandated in the federal Head Start Reauthorization Act of 2007.

Chair Ige and Committee Members:

The Early Learning Council ("ELC") offers this testimony in support of S.B. 931.

Established under Act 14, First Special Session 2008, the Early Learning Council is entrusted with the development and administration of the state's early learning system. The ELC was chartered to establish a cohesive, comprehensive, and sustainable early learning system that ensures a spectrum of quality early learning opportunities for young children from their prenatal period until the time they enter kindergarten.

In establishing the early learning system, the Early Learning Council was directed to coordinate, improve, and expand all existing early learning programs and services by maximizing public and private resources, as well as "[r]ecommend the appropriate proportion of state funds that should be distributed to programs and services across the early learning system, to ensure the most effective and efficient allocation of fiscal resources within the early learning system".

In keeping with this task and the directives as put forth to the ELC by Act 14, the Early Learning Council requires operational funding for these system building efforts and the Council is also working on a long-term and fiscally responsible plan to launch such a system. Developing a fiscal mapping study to include the identification and development of a direct funding stream including public and private funding to support the early learning system_is in accordance with this task.
