SUBJECT: SB 962- RELATING TO CHANGING REFERENCES IN THE

HAWAII REVISED STATUTES FROM "MENTAL RETARDATION"

TO "INTELLECTUAL DISABILITY."

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS SB 962**. The purpose of the bill is to change references to "mental retardation" or like terms in the Hawaii Revised Statutes to "intellectual disability" or like terms.

On October 5, 2010, President Obama signed S. 2781 into law as Public Law (P.L.) 111-256. This law is also known as "Rosa's Law" named after Rosa Marcellino, a nine-year old girl with Down's Syndrome who worked with her mother, Nina, and their state representative who led the effort to pass legislation in Maryland changing the word "mental retardation" to "intellectual disability."

Rosa's law replaces the term "mental retardation" with "intellectual disability" in federal education, health and labor laws. The law states that for purposes of the amended statutes and implementing regulations, a reference to an "intellectual disability" shall mean a condition previously referred to as "mental retardation" and a reference to "individuals with intellectual disabilities" shall be a reference to those previously referred to as "individuals with mental retardation."

The American Association on Intellectual Disabilities and Developmental Disabilities (AAIDD) defines intellectual disability as "a disability characterized by significant limitations both in intellectual functioning and in adaptive behavior, which covers everyday social and practical skills. This disability originates before the age of 18."

The Council has been working with the Self-Advocacy Advisory Council (SAAC) comprised of individuals with intellectual disabilities and the Maternal Child Health Leadership Education in Neurodevelopmental and Related Disabilities (MCH-LEND) program in the movement to remove the "R" word and replace it with intellectual disabilities. SAAC members were overwhelmingly eager to make the change from the terms "mental retardation," "mentally retarded," and "retarded" that they consider being hurtful and offensive, to a term "intellectual disabilities" that is considered to be more positive and respectful to them.

SB 962 seems to be such a simple measure to remove the term "mental retardation" and like terms and replace it with "intellectual disabilities." However, its outcome would be significant and have far reaching effects in:

- 1) Moving in the right direction in keeping with P.L. 111-256
- 2) Changing how we refer to individuals with intellectual disabilities
- 3) Promoting more respectful and people-first language
- 4) Promoting positive attitudes and perceptions of individuals with intellectual disabilities
- 5) Treating individuals with intellectual disabilities with greater dignity and respect

The Council emphasizes Section 19 on Page 8, lines 3-5, that this Act is not intended to change coverage, eligibility, rights, responsibilities or definitions referred to in the amended provisions.

We applaud the Legislature's initiative through SB 962 that recognizes that individuals with intellectual disabilities are people first, and that they have the right to be included and respected in society.

I am Louis Erteschik, Staff Attorney at the Hawaii Disability Rights Center, and am testifying in support of this bill.

The purpose of the bill is to substitute the term "intellectual disabilities" in various sections of the Hawaii Revised Statures where currently the term "mental retardation "appears. While this does not change or affect substantive rights of individuals, the symbolic effect is nonetheless significant and worthy of support.

As our society has evolved, we have come to see terms as "mentally retarded" to be outmoded to say the least and reminiscent of a prior day when it may have, intentionally or unintentionally, contained hurtful connotations. Certainly the term "intellectual disabilities" seems to be a more correct and accurate description of the condition. Additionally, it is our belief that sometimes language and terminology can lead to self fulfilling conduct and all indications from discussions with advocates in the disability community are that this change can provide a greater feeling of self worth and empowerment to this population. That alone, is a worthy goal and a very strong reason to support this bill.



Dear Chairs Tokuda and Chun Oakland and Committee Members,

The Special Education Advisory Council (SEAC), Hawaii's State Advisory Panel under the Individuals with Disabilities Education Act (IDEA), **supports** SB 962 which aims to substitute more current terminology for the sometimes stigmatizing term "mental retardation" in Section 333F-1 of the Hawaii Revised Statutes.

SEAC and other community organizations championed the use of the term "Intellectual Disability" in lieu of "Mental Retardation" as an eligibility category in Hawaii's revisions to special education administrative rules--Chapter 60. In doing so, SEAC was following a national movement led by self advocates to use more neutral and person-centered language in describing disabilities. Most recently, Rosa's Law, passed unanimously by Congress in October 2010, likewise requires the substitution of "intellectual disability" for "mental retardation" in federal health, education and labor policies.

SEAC believes the time has come for Hawaii to abandon old, baggage laden disability terms for respectful, People First language. Thank you for the opportunity to present testimony on this important issue. I would be happy to answer questions should you have any.

My name is Michael A. Ortiz and I am a 2nd year Masters in Social Work Student at the University of Hawaii at Manoa, a practicum student at the Hawaii state council on developmental disabilities, and a MCH LEND (Maternal and Child Health Leadership Education in Neurodevelopmental and Related Disabilities) Trainee at Kapiolani Medical Center for Women and Children. Thank you for the opportunity to tell you that I am in strong support of **SB 962**.

I do not have a family member with a developmental or intellectual disability. I myself do not have a developmental or intellectual disability. I do, however have many friends, clients, and colleagues who have an intellectual or developmental disability. I have heard countless times the stories of pain, anger, and sadness from this group about the verbal and physical torment they have encountered growing up and still experience today. Although I have not been affected by this myself, I cannot help but think of the many times I have been labeled and treated in a negative way due to my race, gender, appearance, and socioeconomic status. When I think back at those times people gave me derogatory labeling for the above mentioned, it reminds me that words have an impact of how we are treated and how we ultimately begin to view ourselves. I myself am not alone, as all of us have fallen victim to this in one way or another.

Still to this day, I do not feel that current ideas, attitudes, and beliefs about individuals with disabilities promote equality. Through the passage of this bill, I feel that it will begin the process of changing the negative ideas, attitudes, and beliefs about individuals with disabilities and will be the catalyst to enhancing their quality of life. I understand that this bill will not change things overnight. However, I feel that someone needs to lead by example and feel that the legislature and state is in the best position to lead this new paradigm of thinking.

My name is Alexa Fong and I am currently pursuing my Master's in Social Work at the University of Hawaii, Manoa. I **strongly support of SB962** and urge the committee to pass this bill to replace the reference to "mental retardation" to "intellectual disability" in the Hawaii Revised Statues. I have been working with children and adults with developmental disabilities for five years and have seen the many ways in which society denies these individuals the basic right to live a self-determined life, unbounded by discrimination.

Words are very powerful and the word "retarded" perpetuates a destructive stigma throughout our society. Because the label "mentally retarded" has adopted a powerful negative connotation, the use of this word to categorize a person with cognitive disabilities prohibits the inclusion and acceptance of persons with such disabilities in our community. Moreover, bill SB962 seeks to regard the person first and does not define a person solely by their disability. Hawai'i's legislature has the opportunity to be on the forefront of change, supported by our federal government and the enactment of Rosa's Law. In Hawai'i, we pride ourselves on our diverse peoples and cultures. Let us continue to celebrate our differences but also foster respect and inclusively in our community.

Many government agencies and organizations throughout the nation are moving towards the elimination of the label "mental retardation." In addition to federal changes in 2010 with Rosa's Law, in 2003, President Bush changed the name of his Committee on Mental Retardation to the President's Committee on Intellectual Disability. Currently, the Diagnostic Manual on Mental Disorders (DSM) is being changed to reflect the name

change in the clinical diagnosis. Therefore, the question is not *should* we eliminate the term from our statues, but when.

My name is James Mariano. I am a resident of Maui County.

Thank you for the opportunity to tell you that I am in strong support of SB 962.

I have been working in the field of aging and disability for 11 years, both professionally and as a volunteer.

The long-standing usage of the label 'mentally retarded' is not only wholly offensive, but irresponsible. Notwithstanding its negative connotation, the label does not accurately describe an individual's capabilities and potential. Like other damaging labels, these words are ingrained in the language and have been all too commonplace. It concerns me that this word is pervasive in the field of health and human services, and that its de facto usage is reinforced by statutes that need updating.

Change is difficult but it has to start somewhere. Times have changed. More and more people with mental challenges have become mainstreamed. They are no longer the minority that many wanted them to be.

This bill needs to pass so that we can send a clear message that language is important. It is important to know that what we say is as important as how we say it. It is empowering to celebrate the intrinsic person. This bill allows the governing body to change this part of the language in our law. It is so much more than being politically correct—it is about recognizing the self-worth of all citizens.
