I, Cynthia Stemmer Denny, am in support of Christine Ho's request to obtain a "yes" vote in favor of the resolution to allow the 55 year non-exclusive easement covering a portion of state submerged lands pursuant to section 17153, HRS; relating to the reclamation and disposition of submerged or reclaimed public land abutting the property at 303 Front Street, Lahaina, HI.

This particular seawall as a predominant structure along the Lahaina coastline is extremely important for the preservation of land and property in this neighborhood. The wall contributes to the front line defense of an erosion control barrier in the protection of life and property against eminent danger attributed to future potential ocean tsunamis and turbulence. The coral reef in this area is our primary defense and the seawalls act as our secondary back up. Christine Ho is dedicated to the mission at hand.
