Testimony in support of HCR 163

Veterans on the Big Island are sorely in need of a Veterans' Center that will centralize services for veterans to a single location. Hawaii Island is the only one of the major islands without a Veteran Center, yet the distance within the island are much greater. Having a Veterans Center co-locating various needed services would facilitate Veterans traveling to these facilities for needed services.

These services include a Community Based Outpatient Clinic, a central meeting place for veterans organizations, service organizations such as the Office of Veterans Affairs, the Office of the Department of Defense and office of Veteran Services, social and recreation facility for veterans, reservists, and active duty military. The facility will also house offices for veterans organizations that would be centrally located to better organize plan and implement veteran and social programs. Such an organization is the West Hawaii Veterans Cemetery Association (WHVCA) which will effectively manage the Veteran Center.

The WHVCA membership working cooperatively with government agencies, civic groups, businesses and hundreds of volunteers contributed to the coveted shrine status awarded the West Hawaii Veterans Cemetery earlier this year. Particularly noteworthy are the WHVCA efforts that help transform the notorious reputed "Boot Hill" of the cemetery for which the voices of many veterans were heard to say "I don't want to be buried here" to the shrine status where now many veterans have asked "Do you take reservations?"

We are particularly proud of the native reforestation program wherein hundreds of volunteers spending thousands of hours in the past five (5) years have transformed and restored an invasive fountain grass pu'u into a verdant hill of four thousand trees native and shrubs earning in the process a Congressional and numerous local awards and recognition. We are particularly gratified to have initiated hundreds of young men and women student volunteers to the gratifying and self fulfillment of public service which will have lasting, incalculable, positive effects upon our society.

Please support our veterans center in filling their defined needs and enabling the facilitation of our continuing veteran and social programs.

In the words of our Charter President of the WHVCA Mr. Richard Highley, paraphrased as reported to the press: "We come not with our hands out but with our sleeves rolled up and with picks and shovels in our hands"

**TESTIMONY OF
JOHN GROGAN, PRESIDENT - WEST HAWAII VETERANS COUNCIL
REGARDING HR 142 / HCR 163
SETTING ASIDE STATE LAND FOR A WEST HAWAII VETERANS CENTER
APRIL 13, 2011**

Aloha, Chair Oshiro, Vice-Chair Lee and Members of the House Finance Committee:

I am a six year U.S. Navy veteran with Vietnam service. On behalf of the West Hawaii Veterans Council, I ask for your Committee's favorable approval of our request that sixty (60) acres of State land in West Hawaii be set aside for the purpose of creating a West Hawaii Veterans Center. There are Veteran Centers on the islands of Oahu, Kauai, and Maui that have lead the way and shown how important these centers are for our veterans, and the communities at large. They have also been most helpful in providing us guidance and support for establishing a Veterans Center in West Hawaii.

The State Department of Veterans Services acknowledges that we have 17,000 veterans living on the island of Hawaii. It is estimated that half that number live in West Hawaii - from Kohala to Ka'u. These Concurrent Resolutions HCR 163 (HR142) propose that a centralized Veterans' Center be built midway along the main north - south bus corridor off Queen Ka'ahumanu Hawaii.

There is widespread community support for this centralized Veterans' Center as evidenced by the more than 500 citizens who, during a seven-day period in March, signed Petitions supporting the Veterans Center. Ms. Virginia Isbell will appear in person before the Finance Committee to represent West Hawaii veterans and will provide the Petitions to the Committee.

As the lead 501(c)(3) organization, requesting the Legislature's approval setting aside state land for a West Hawaii Veterans' Center, please be advised that our Association consists of representatives of all the major active veterans' organizations in West Hawaii and that our By-Laws do permit our involvement in veterans' issues that include establishment of a Veterans Center. Our primary focus in the past, however, was being the unofficial caretaker of the West Hawaii Veterans Cemetery.

Representatives of the major veterans' organizations in West Hawaii came together recently to establish a new organization to focus on Veterans' Center issues. This organization, West Hawaii Veterans Council (WHVC), has adopted Articles of Incorporation and By-Laws for this purpose. Officers and directors have been elected and the Council is under the umbrella of the 501(c)(3) while processing the paperwork and proceeding with the first step that is the land set-aside.

We are well aware of the provision that when the West Hawaii Veterans' Center has been established, it must be self-sustaining. We are prepared to achieve that requirement by offering the facility for rent to West Hawaii community organizations and for individual purposes such as funeral services, weddings, and various gatherings.

The proposed Veterans Center site is in the Maniniowali-Awake'e Area of Kona near the West Hawai'i Veterans Cemetery.

The Veterans' Center will be well-managed because we veterans have had the responsibility of overseeing the Veterans Cemetery and we have taken that responsibility very seriously.

I am pleased to inform you that the U.S. Department of Veterans Affairs has designated the West Hawai'i Veterans Cemetery as achieving "**Shrine**" status - one of only three State Veterans Cemeteries in America so designated.

Thank you for the opportunity to testify and we ask for your favorable consideration of our request.
