

A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the constitution of the State of Hawaii.
- 4 SECTION 2. The purpose of this Act is to make an emergency
- 5 appropriation to fund the voting system contract for the 2012
- 6 elections. Without an emergency appropriation the office of
- 7 elections will not be able to fulfill its current voting system
- 8 contract or conduct the 2012 elections. Additionally, the State
- 9 of Hawaii will be out of compliance with its obligations under
- 10 the Help America Vote Act of 2002, Public Law 107-252.
- 11 Title 42 United States Code section 15481 of the Help
- 12 America Vote Act of 2002 mandates various voting system
- 13 standards. The currently unfunded voting system contract will
- 14 allow the State of Hawaii to meet those standards.
- 15 Further, title 42 United States Code section 15404(a)(7) of
- 16 the Help America Vote Act of 2002 mandates, as a condition of
- 17 the receipt of federal payments, the maintenance of expenditures
- 18 of the recipient state for activities funded by federal payments HB2437 HD1 HMS 2012-1639



- 1 at a level that is not less than the level of such expenditures
- 2 maintained by the state for the fiscal year ending prior to
- 3 November 2000. The level of such expenditures in fiscal year
- 4 1999-2000 was \$2,299,552. The State of Hawaii has always met
- 5 this requirement. The present operating budget of the office of
- 6 elections for fiscal year 2011-2012 is \$1,829,581. Unless
- 7 supplemented by an emergency appropriation, the State of Hawaii
- 8 will not meet this expenditure requirement, which will
- 9 compromise prior and future federal funding.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$1,725,000 or so much
- 12 thereof as is necessary, for fiscal year 2011-2012 for the
- 13 purpose of funding the payment of the voting system contract for
- 14 the 2012 elections.
- The sum appropriated shall be expended by the department of
- 16 accounting and general services for the purposes of this Act.
- 17 SECTION 4. This Act shall take effect upon its approval.
