A BILL FOR AN ACT

RELATING TO VACCINATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	TION 1. The legislature finds that Act 125, Session
2	Laws of H	awaii 2010, was adopted to form a task force convened
3	by the Ha	waii state board of pharmacy to research, assess, plan,
4	and evalu	ate, among other things:
5	(1)	The potential benefits and drawbacks of reducing the
6		age restrictions that prevent children from receiving
7	•	vaccines from pharmacists;
8	(2)	The most effective means to reduce such age
9		restrictions;
10	(3)	Whether additional education or certification
11	•	requirements would be necessary or recommended to
12		allow pharmacists to administer vaccines to children;
13	(4)	Schemas of vaccination age restrictions of other
14		states that allow vaccination of minors by pharmacists
15		in all or limited circumstances; and
16	(5)	The feasibility of implementing recommended changes.
17	The task	force developed the recommendation that with a
18	physician	's prescription, and provided that certain educational

- 2 influenza vaccine to a person between fourteen and seventeen
- 3 years of age.
- 4 The purpose of this Act is to enact a recommendation made
- 5 by the immunizations task force established pursuant to Act 125,
- 6 Session Laws of Hawaii 2010, to allow pharmacists to administer
- 7 the influenza vaccine to persons between fourteen and seventeen
- 8 years of age, under certain conditions.
- 9 SECTION 2. Chapter 461, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "§461- Influenza vaccinations; children. (a) A
- 13 pharmacist may administer the influenza vaccine to persons
- 14 between fourteen and seventeen years of age pursuant to a valid
- 15 prescription. The pharmacist shall verify that the prescriber
- 16 or the prescriber's authorized agent is the patient's medical
- 17 home.
- 18 (b) After the vaccination is administered, the pharmacist
- 19 shall immediately provide to the patient a vaccination record
- 20 including but not limited to the following information:
- 21 (1) The patient's name and date of birth;
- 22 (2) The type of vaccine administered; and

1	(3) The date and location on which the vaccine was			
2	administered.			
3	(c) The pharmacist shall provide within seventy-two hours			
4	to the medical home and within five business days to the			
5	department of health immunization registry the same information			
6	provided to the patient pursuant to subsection (b) as well as			
7	the following:			
8	(1) The name of the vaccine product that was administered,			
9	including the manufacturer, lot number, and expiration			
10	<pre>date;</pre>			
11	(2) The method of administration; and			
12	(3) The anatomical site of administration.			
13	(d) All pharmacists who administer the influenza vaccine			
14	to persons between the ages of fourteen and seventeen years			
15	shall complete a training program approved by the Accreditation			
16	Council of Pharmacy Education for which a certificate of			
17	completion is issued. The pharmacist shall complete the			
18	training program and submit the completion certificate for the			
19	training program to the board prior to administering the			
20	influenza vaccine to persons between the ages of fourteen and			
21	seventeen years.			

1	(e) For the purposes of this section, "medical home" means				
2	the primary care physician who, working in collaboration with				
3	the family, oversees the acute, chronic, and preventive health				
4	needs of the patient in a comprehensive, coordinated, and				
5	continuous fashion."				
6	SECTION 3. Section 461-1, Hawaii Revised Statutes, is				
7	amended by amending the definition of "practice of pharmacy" to				
8	read as follows:				
9	""Practice of pharmacy" means:				
10	(1) The interpretation and evaluation of prescription				
11 .	orders; the compounding, dispensing, and labeling of				
12	drugs and devices (except labeling by a manufacturer,				
13	packer, or distributor of nonprescription drugs and				
14	commercially legend drugs and devices); the				
15	participation in drug selection and drug utilization				
16	reviews; the proper and safe storage of drugs and				
17	devices and the maintenance of proper records				
18	therefore; the responsibility for advising when				
19	necessary or where regulated, of therapeutic values,				
20	content, hazards, and use of drugs and devices;				
21	(2) Performing the following procedures or functions as				
22	part of the care provided by and in concurrence with a

20			Pharmaceutical Education (ACPE), curriculum-based

1		programs, or programs recognized by the board of
2		pharmacy;
3	(D)	Administering drugs orally, topically, by
4		intranasal delivery, or by injection, pursuant to
5		the patient's licensed physician's order, by a
6		pharmacist having appropriate training that
7		includes programs approved by the ACPE,
8		curriculum-based programs from an ACPE-accredited
9		college of pharmacy, state or local health
10		department programs, or programs recognized by
11		the board of pharmacy;
12	(E)	Administering [immunizations]:
13		(i) Immunizations orally, by injection, or by
14		intranasal delivery, to persons eighteen
15		years of age or older[-] by a pharmacist
16		having appropriate training that includes
17		programs approved by the ACPE, curriculum-
18		based programs from an ACPE-accredited
19		college of pharmacy, state or local health
20		department programs, or programs recognized
21		by the board of pharmacy; and

•		(11) The militadiza vaccine to persons between
2		fourteen and seventeen years of age pursuant
3		to section 461- ;
4	(F)	As authorized by a licensed physician's written
5		instructions, initiating or adjusting the drug
6		regimen of a patient pursuant to an order or
7		authorization made by the patient's licensed
8		physician and related to the condition for which
9		the patient has been seen by the licensed
10		physician; provided that the pharmacist shall
11		issue written notification to the patient's
12	•	licensed physician or enter the appropriate
13	•	information in an electronic patient record
14		system shared by the licensed physician, within
15		twenty-four hours;
16	(G)	Transmitting a valid prescription to another
17		pharmacist for the purpose of filling or
18		dispensing; or
19	(H)	Providing consultation, information, or education
20		to patients and health care professionals based
21		on the pharmacist's training and for which no
22		other licensure is required; and

1	(3) The offering or performing of those acts, services,
2	operations, or transactions necessary in the conduct,
3	operation, management, and control of pharmacy."
4	SECTION 4. Section 461-8, Hawaii Revised Statutes, is
5	amended to read as follows:
6	"§461-8 Renewal of licenses; continuing education
7	requirement. (a) All licenses issued by the board, except
8	temporary licenses issued under section 461-7, shall be renewed
9	biennially on or before December 31 of each odd-numbered year.
10	Failure to pay the biennial fee and, beginning with the renewal
11	for the licensing biennium commencing on January 1, 2008, to
12	satisfy the continuing education requirement on or before
13	December 31 of each odd-numbered year, shall constitute a
14	forfeiture of the license as of the date of expiration.
15	(b) Any license forfeited pursuant to subsection (a) may
16	be restored within three years upon payment of any penalty fee,
17	the current biennial fees, and the renewal fee for the next
18	biennium, if applicable, upon submission of proof of compliance
19	with the continuing education requirement for the prior
20	biennium, and upon meeting any other requirements specified in
21	rules adopted pursuant to chapter 91.

1	(c) In the event that the pharmacist has not engaged in
2	the practice of pharmacy in this State or in another state or
3	territory of the United States within the past five years, the
4	board may require the pharmacist to satisfy additional
5	requirements, as specified in rules adopted pursuant to chapter
6	91, to demonstrate that the pharmacist is competent to practice
7	in this State.
8	(d) Beginning with the renewal for the licensing biennium
9	commencing on January 1, 2008, and every biennial renewal
10	thereafter, each licensee shall have completed thirty credit
11	hours in continuing education courses within the two-year period
12	preceding the renewal date, regardless of the licensee's initial
13	date of licensure; provided that a licensee who has graduated
14	from an accredited pharmacy school within one year of the
15	licensee's first license renewal period shall not be subject to
16	the continuing education requirement for the first license
17	renewal. The board may extend the deadline for compliance with
18	the continuing education requirement based on any of the

12	other biennial renewal period and submit proof of successful			
13	completion of the training program to the board; provided that			
14	the pharm	acist shall meet these requirements prior to		
15	administe	ring the influenza vaccine to persons between the ages		
16	of fourte	en and seventeen years.		
17	[-(e)] <u>(f)</u> Each licensee shall maintain the licensee's		
18	continuin	g education records. At the time of renewal, each		
19	licensee shall certify under oath that the licensee has complied			
20	with the continuing education requirement of this section. The			
21	board may	require a licensee to submit, in addition to the		
22	certifica	tion, evidence satisfactory to the board that

- 3 [(f)] (g) The board may conduct random audits to determine
- 4 compliance with the continuing education requirement. The board
- 5 shall provide written notice of an audit to a licensee randomly

- 7 licensee shall provide the board with documentation verifying
- 8 compliance with the continuing education requirement."
- 9 SECTION 5. Section 461-21, Hawaii Revised Statutes, is
- 10 amended by amending subsection (a) to read as follows:
- "(a) In addition to any other actions authorized by law,
- 12 the board shall have the power to deny, revoke, or suspend any
- 13 license or permit applied for or issued by the board in
- 14 accordance with this chapter, and to fine or otherwise
- 15 discipline a licensee or permit holder for any cause authorized
- 16 by law, including but not limited to the following:
- 17 (1) Procuring a license through fraud, misrepresentation,
- 19 (2) Professional misconduct, gross carelessness, or
- 20 manifest incapacity;
- 21 (3) Permitting an unlicensed person to perform activities
- 22 [which] that require a license under this chapter;

2		the rules adopted pursuant thereto;
3	(5)	Violation of any state or federal drug, controlled
4		substance, or poison law;
5	(6)	False, fraudulent, or deceptive advertising;
6	(7)	Any other conduct constituting fraudulent or dishonest
7		dealings;
8	(8)	Failure to comply with a board order;
9	(9)	Making a false statement on any document submitted or
10		required to be filed by this chapter, including a
11		false certification of compliance with the continuing

13	(10)	Habitual intemperance or addiction to the use of
