## A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING COST ITEMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 2 SECTION 7. Salary increases and cost adjustments provided
- 3 in this Act for any officer or employee whose compensation is
- 4 paid, in whole or in part, from federal, special, or other funds
- 5 shall be paid wholly or proportionately, as the case may be,
- 6 from the respective funds.
- 7 SECTION 8. Funds appropriated or authorized by this Act
- 8 that are not expended or encumbered by June 30, 2012, and June
- 9 30, 2013, of the respective fiscal years, shall lapse as of
- 10 those dates.
- 11 SECTION 9. This Act shall take effect upon its approval
- 12 and shall apply retroactively to July 1, 2011.
