A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I 1 SECTION 1. There are appropriated or authorized from the 2 sources of funding indicated below to departmental 3 administration and budget division (BUF 101) the following sums, 4 or so much thereof as may be necessary, to fund for fiscal 5 biennium 2011-2013 the salary increases and other cost 6 adjustments related to "favored nations" provisions in the 8 supplemental agreement negotiated between the department of education and the exclusive bargaining representative of 9 collective bargaining units 2, 3, 4, 6, and 13 for employees of 10 the department of education, including the Hawaii state public 11 12 library system:
