## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I			
2	SECTION 1. There are appropriated or authorized from the			
3	general fund to the Hawaii employer-union trust fund the			
4	following sums, or so much thereof as may be necessary, to fund			
5	for fiscal biennium 2012-2013 the Hawaii employer-union health			
6	benefits trust fund costs contained in the supplemental			
7	agreements negotiated between the University of Hawaii and the			
8	exclusive bargaining representative of collective bargaining			
9	unit 7 and authorized by chapter 89C, Hawaii Revised Statutes,			
10	for state officers and employees excluded from collective			
11	bargaining who belong to the same compensation plans as those			
12	officers and employees within collective bargaining unit 7:

15	SECTION 2. Funds appropriated or authorized by this part			
16	shall be allotted by the director of finance to the appropriate			
17	state agencies for expenditure in the respective fiscal year for

- 2 SECTION 3. Cost adjustments provided in this Act for any
- 3 officer or employee whose compensation is paid, in whole or in
- 4 part, from federal, special, or other funds shall be reimbursed
- 5 wholly or proportionately, as the case may be, from the
- 6 respective funds.
- 7 SECTION 4. Funds appropriated or authorized by this Act
- 8 that are not expended or encumbered by June 30, 2012, and
- 9 June 30, 2013, of the respective fiscal years, shall lapse as of
- 10 those dates.
- 11 SECTION 5. This Act shall take effect upon its approval.
