A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 213, Hawaiian Homes Commission Act,
2	1920, as amended, is amended by amending subsection (d) to read
3	as follows:
4	"(d) There are established in the treasury of the State
5	four trust funds, to be known respectively as the Hawaiian home
6	operating fund, the Hawaiian home receipts fund, the Hawaiian
7	home trust fund, and the native Hawaiian rehabilitation fund,
8	and one special fund to be known as the Hawaiian home
9	administration account. Expenditures and procurements less than
10	\$100,000 made from these trust funds and accounts shall be
11	exempt from chapter 103D, Hawaii Revised Statutes; provided that
12	the department shall develop internal policies and procedures
13	for the procurement of goods, services, and construction that
14	are consistent with the goals of public accountability and
15	public procurement practices for expenditures from these funds.
16	The department is encouraged to use the provisions of chapter
17	103D, Hawaii Revised Statutes, where possible; provided that the
18	use of one or more provisions of chapter 103D, Hawaii Revised

- 1 Statutes, shall not constitute a waiver of the exemption from
- 2 that chapter and shall not subject the department to any other
- 3 provision of chapter 103D, Hawaii Revised Statutes.
- 4 The department shall submit an annual report to the
- 5 legislature no later than twenty days before the convening of
- 6 each regular session. The report shall include, but not be
- 7 limited to, solicitations of goods, services, and construction,
- 8 types of procurements, and awardees."
- 9 SECTION 2. New statutory material is underscored.
- 10 SECTION 3. This Act shall take effect on July 1, 2012;
- 11 provided that on June 30, 2015, this Act shall be repealed and
- 12 section 213, Hawaiian Homes Commission Act, 1920, as amended,
- 13 shall be reenacted in the form in which it read on June 30,
- **14** 2012.
