A BILL FOR AN ACT

RELATING TO THE MORTGAGE RESCUE FRAUD PREVENTION ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 480E, Hawaii Revised Statutes, is 2 amended by adding two new sections to be appropriately 3 designated and to read as follows: 4 Mortgage rescue fraud; consumer education. "§480Eoffice of consumer protection shall educate consumers about 5 6 fraudulent activities that may be committed against homeowners 7 who face property foreclosures, liens, or encumbrances, as 8 appropriate. 9 \$480E-Criminal penalties. Any person who violates 10 section 480E-10 is guilty of a class C felony and, in addition 11 to any other penalties, shall be fined \$10,000." 12 SECTION 2. Section 480E-11, Hawaii Revised Statutes, is 13 amended by amending its title to read as follows: 14 "[{] §480E-11[] Violation,] Unfair or deceptive act or 15 practice; penalties."
- 16 SECTION 3. This Act does not affect rights and duties that
- 17 matured, penalties that were incurred, and proceedings that were
- 18 begun before its effective date.
