A BILL FOR AN ACT

RELATING TO SEXUAL IMAGES PRODUCED BY MINORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 712, Hawaii Revised Statutes, is		
2	amended by adding two new sections to part II to be		
3	appropriately designated and to read as follows:		
4	"§712- Promoting minor-produced sexual images in the		
5	first degree. (1) A person, eighteen years of age or older,		
6	commits the offense of promoting minor-produced sexual images in		
7	the first degree if the person intentionally or knowingly		
8	commands, requests, or encourages a minor to use a computer,		
9	cell phone, or any other device capable of electronic data		
10	transmission or distribution, to transmit to any person a nude		
11	photograph or video of a minor.		
12	(2) For purposes of this section, a "minor" means any		
13	person under eighteen years of age.		
14	(3) Promoting minor-produced sexual images in the first		
15	degree is a misdemeanor.		
16	§712- Promoting minor-produced sexual images in the		
17	second degree. (1) A minor commits the offense of promoting		
18	minor-produced sexual images in the second degree if the minor:

1	<u>(a)</u>	Knowingly uses a computer, cell phone, or any other
2		device capable of electronic data transmission or
3		distribution, to transmit or distribute to another
4		person a nude photograph or video of a minor or the
5		minor's self; or
6	<u>(b)</u>	Intentionally or knowingly commands, requests, or
7		encourages another minor to use a computer, cell
8		phone, or any other device capable of electronic data
9		transmission or distribution, to transmit to any
10		person a nude photograph or video of a minor or the
11		minor's self.
12	(2)	A person, of any age, commits the offense of promoting
13	minor-pro	duced sexual images in the second degree if the person
14	knowingly	possesses a nude photograph or video of a minor
15	transmitt	ed or distributed in violation of subsection (1). It
16	is an aff	irmative defense under this subsection that the person
17	took reas	onable steps to destroy or eliminate the nude
18	photograp	h or video of a minor.
19	(3)	For purposes of this section, a "minor" means any
20	person un	der eighteen years of age.
21	(4)	Promoting minor-produced sexual images in the second
22	degree is	a petty misdemeanor."
