## A BILL FOR AN ACT

RELATING TO HEALTH.

	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that bone marrow
2	transplantation services are not available in the State. This
3	procedure is used to treat patients with leukemia, aplastic
4	anemia, lymphomas such as Hodgkin's disease, multiple myeloma,
5	immune deficiency disorders, and some solid tumors such as
6	breast and ovarian cancer.
7	The purpose of this Act is to implement a bone marrow
8	transplantation program in the State by appropriating funds as a
9	grant for Kapiolani Medical Center for Women and Children to
10	establish an apheresis stem cell collection program to support
11	pediatric bone marrow transplantation to serve all young
12	children to adulthood.
13	SECTION 2. There is appropriated out of the general
11	revenues of the State of Hawaii the sum of \$500 000 or so much

13 14 revenues of the State of Hawall the sum of \$500,000 or so much 15 thereof as may be necessary for fiscal year 2012-2013 as a grant 16 pursuant to chapter 42F, Hawaii Revised Statutes, for Kapiolani **17** Medical Center for Women and Children to establish an apheresis

- 2 transplantation to serve all young children to adulthood.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 3. This Act shall take effect on July 1, 2012.
