#### STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 283

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 283, entitled "A Bill for an Act Relating to State Funds."

The purposes of this bill are to: (1) authorize the transfer during fiscal year 2012-2013 of \$196,000 from the Agricultural Loan Revolving Fund to the Pest Inspection, Quarantine, and Eradication Fund; and (2) appropriate \$196,000 for fiscal year 2012-2013 from the Pest Inspection, Quarantine, and Eradication Fund to be expended by the Department of Agriculture for a program to control and eradicate the coffee berry borer, including the destruction of feral coffee trees.

The transfer and use of moneys from the Agricultural Loan Revolving Fund for coffee berry borer control and eradication is not necessary. The Department of Agriculture has barrel tax funds available for control and eradication of this pest. Use of its barrel tax funds will enable the Department of Agriculture to address the coffee berry borer infestation while also preserving the use of moneys in the Agricultural Loan Revolving Fund to effectively promote agricultural development in the State.

For the foregoing reasons, I am returning House Bill No. 283 without my

## A BILL FOR AN ACT

RELATING TO STATE FUNDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to address state
- 2 funds by authorizing the transfer of excess moneys in the
- 3 agricultural loan revolving fund to the pest inspection,
- 4 quarantine, and eradication fund and to appropriate the
- 5 transferred moneys for an agricultural program.
- 6 SECTION 2. The legislature determines that there is in the
- 7 agricultural loan revolving fund at least \$196,000 in excess of
- 8 the requirements of the fund. At any time during fiscal year
- 9 2012-2013, the director of finance is authorized to transfer the
- **10** sum of \$196,000 or so much thereof as may be necessary for
- fiscal year 2012-2013 from the agricultural loan revolving fund 11
- 12 to the pest inspection, quarantine, and eradication fund.
- 13 There is appropriated out of the pest SECTION 3.
- 14 inspection, quarantine, and eradication fund the sum of \$196,000
- 15 or so much thereof as may be necessary for fiscal year 2012-2013
- 16 for a program to control and eradicate the coffee berry borer,
- 17 including the destruction of feral coffee trees.

- 1 The sum appropriated shall be expended by the department of
- 2 agriculture for the purposes of this Act.
- 3 SECTION 4. This Act shall take effect on July 1, 2012.
