A BILL FOR AN ACT

RELATING TO LIQUOR.

STATE OF HAWAII

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 281-31, Hawaii Revised Statutes, is	
2	amended by amending subsection (b) to read as follows:	
3	" (b)	Class 1. Manufacturer license. A license for the
4	manufacture of liquor shall authorize the licensee to	
5	[manufacture]:	
6	(1)	Manufacture the liquor therein specified [and to
7		sell];
8	(2)	Sell it [at wholesale] in original packages to any
9		[person] wholesaler who holds a license to resell it
10	٠	[and to sell draught]; and
11	(3)	Sell beer [er] wine [manufactured from grapes or
12		other fruits grown in the State], or other specified
13		liquor manufactured or distilled on the licensee's
14		premises from fruits or other products grown in the
15		State, in any quantity [to]:
16		(A) At wholesale in original packages to any person
17		who holds a license to resell it; and

- 1 (B) To any person for private use and consumption.
- 2 Under this license, no liquor shall be consumed on the
- 3 premises, except as authorized by the commission. Of this
- 4 class, there shall be the following kinds:
- 5 (1) Beer;
- 6 (2) Wine;
- 7 (3) Alcohol; and
- 8 (4) Other specified liquor.
- 9 It shall be unlawful for any holder of a manufacturer
- 10 license to have any interest whatsoever in the license or
- 11 licensed premises of any other licensee. This subsection shall
- 12 not prevent the holder of a manufacturer license under this
- 13 chapter or under the law of another jurisdiction from
- 14 maintaining any interest in the license or licensed premises of
- 15 a wholesale dealer licensee under this chapter."
- 16 SECTION 2. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 3. This Act shall take effect upon its approval.
