A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that a strong public
- 2 library system contributes to the economic, educational, and
- 3 cultural vitality of the State.
- 4 The legislature further finds that under existing law, the
- 5 state librarian may issue licenses, revocable permits,
- 6 concessions, and rights of entry to only two entities: the
- 7 Hawaii State Library Foundation and Friends of the Library of
- 8 Hawaii. The legislature finds that there is concern that
- 9 allowing exclusive use of state facilities creates a special
- 10 privilege for specific private entities even though other
- 11 private entities may be able to provide an equal or greater
- 12 benefit to the Hawaii state public library system if given an
- 13 equal opportunity to participate. The original intent of the
- 14 existing law was not to create exclusive-use privileges but
- 15 rather to encourage greater private-public partnerships to
- 16 benefit the Hawaii state public library system at the community
- 17 level.

4		Foundation and Friends of the Library of Hawaii in
5		chapter 312, Hawaii Revised Statues, in order to
6		remove any appearance of a special privilege to
7		specific entities;
8	(7)	Require the board of education to determine the amount
9		of net income or proceeds received from the operation
10		of any concession, vending machine, or other for-
11		profit business enterprise within or on state library
12		facilities to be deposited into the libraries special
13		fund;
14	(8)	Clarify that nothing in section 312-3.8, Hawaii
15		Revised Statutes, shall be construed to require a
16		library to issue a license, permit, concession, or
17		right of entry in order for any entity to establish a
18		tax-exempt nonprofit corporation recognized under
19		section 501(c)(3) of the Internal Revenue Code whose
20		primary purpose is to support and benefit that library
21		or for any entity or individual to donate funds
22		exclusively to that library;

1	(9)	Clarify that book sales held within, or on the grounds
2		of, any state library facility shall not constitute a
3		concession;
4	(10)	Require the board of education to adopt rules pursuant

15	and entit	ies to support their local libraries.

18		bequeathed, devised, or in any manner received from
19		sources other than the legislature or any federal
20		appropriation for any or all purposes of the
21		libraries;

- 12 facilities. (a) Notwithstanding any law to the contrary, the
- 13 Hawaii state public library system, through the head librarian
- 14 of each library branch, with the approval of the state
- 15 librarian, and in consultation with the board of education,
- 16 shall be authorized to issue licenses, revocable permits,
- 17 concessions, or rights of entry [to the Hawaii state library
- 18 foundation and the friends of the library of Hawaii] for the use
- 19 of public library system facilities and grounds and for [such]

All funds contributed to 14 the trust fund, including income and capital gains earned 15 therefrom, shall be used exclusively for state library programs 16 as defined in the articles, bylaws, resolutions, and other 17 instruments executed on behalf of the Hawaii state library 18 foundation or by the state librarian. The trust fund may 19 receive any and all types of private contributions, and the 20 income and capital gains earned by the fund; provided that funds 21 or properties donated for library use and patrons' deposits

shall be deposited and accounted for in accordance with rules

1	adopted by the comptroller. The trust fund shall be subject to
2	the following restrictions:
3	(1) All funds, and the income and capital gains earned by
4	investment of those funds, shall be expended only for
5	the support of state library programs; and
6	(2) Other restrictions imposed by the legislature with
7	respect to the transfer or appropriation of funds.
8	(b) Any funds deposited in the trust fund, and any income
9	and capital gains earned therefrom, not used for state library
10	programs, shall be invested in accordance with the provisions of
11	the articles, bylaws, resolutions, or other instruments executed
12	on behalf of the Hawaii state library foundation, and in a
13	manner intended to maximize the rate of return on investment of
14	the fund.
15	(c) If the trust fund is terminated or the Hawaii state
16	library foundation is dissolved, all funds, including the income
17	and capital gains earned by the investment of funds, shall be
18	distributed in accordance with the articles and bylaws of the
19	Hawaii state library foundation.
20	(d) The Hawaii state library foundation shall require an
21	annual audit of the trust fund, the results of which shall be
22	submitted to the department of education not more than thirty

- 1 days after receipt by the foundation. The foundation shall
- 2 retain for a period of three years, any documents, papers,
- 3 books, records, and other evidence that is pertinent to the
- 4 trust fund, and permit inspection or access thereto by the
- 5 department of education, the state librarian, the department of
- 6 accounting and general services, state legislators, and the
- 7 state auditor, or their duly authorized representatives.
- 8 (e) The purpose of this section is to create by statute a
- 9 private charitable trust fund to financially support state
- 10 library programs. The trust fund shall be subject to the terms
- 11 and conditions provided in this section. The trust fund shall
- 12 not be placed in the state treasury and the State shall not
- 13 administer the fund nor be liable for its operation or solvency.
- 14 The fund shall be a private charitable trust fund administered
- 15 by a private trust company as trustee."]
- 16 SECTION 6. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 7. This Act shall take effect upon its approval.

Education; State Libraries

Description:

Clarifies that the board of education may enter into an agreement with any tax-exempt nonprofit corporation recognized under section 501(c)(3) of the Internal Revenue Code or an affiliate to obtain the use of the books and property and income of that nonprofit corporation or its affiliate. Authorizes the deposit of private donations and moneys collected pursuant to section 312-3.8, HRS, into the libraries special fund. Clarifies that privately donated moneys for the benefit of a specific public library shall be disbursed to the specified public library for the sole use of that library. Clarifies that the state librarian may establish subaccounts within the libraries special fund. Amends section 312-3.8, HRS, to: authorize the head librarian of each library branch, with the approval of the state librarian, and in consultation with the board of education, to issue licenses, revocable permits, concessions, or rights of entry for the use of public library facilities and grounds; (2) remove references to the Hawaii state library foundation and friends of the library of Hawaii; (3) require the board of education to determine the amount of net income or proceeds received for the operation of any concession, vending machine, or other for-profit business enterprise within or on state library facilities that shall be deposited into the libraries special fund; (4) clarify that nothing in section 312-3.8, HRS, shall be construed to require a library to issue a license, permit, concession, or right of entry in order for any entity to establish a tax-exempt nonprofit corporation recognized under section 501(c)(3) of the Internal Revenue Code whose primary purpose is to support and benefit that library or to donate funds exclusively to that library; (5) clarify that any book sale held within, or on the grounds of, any state library facility is not a concession; and (6) require the board of education to adopt administrative Repeals the Hawaii state library foundation trust fund. rules.
