BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The legislature finds that students who do not
2	hold a lawful immigration status encounter extreme hardship
3	attending public institutions of higher education in the State,
4	as they must pay a nonresident tuition and fee differential and
5	are not eligible for financial assistance. Many of these
6	students have lived in the State for the majority of their lives
7	and have thrived socially and academically. In addition, many
8	are unaware of their immigration status until they apply for
9	admission to institutions of higher education.
10	The legislature further finds that permitting these
11	students to access higher education with the same benefits as
12	resident citizens is in the public interest as it will allow
13	them to fully realize their potential as productive members of
14	society.
15	Under the federal Immigration and Nationality Act, states
16	have the authority to grant state and local public benefits to
17	residents who do not have lawful immigration status. The

purpose of this Act, therefore, is to assist students who do not

- 6 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 7 amended by adding a new section to be appropriately designated
- 8 and to read as follows:
- 9 "\$304A- Resident noncitizens; tuition; financial aid.
- 10 (a) Students who are exempt from the nonresident tuition and
- 11 fee differential under section 304A-502(c) shall be eligible to
- 12 apply for and participate in all student financial aid and
- 13 university programs administered by the university to the full
- 14 extent permitted under federal law.
- 15 (b) The board of regents shall adopt rules and procedures
- 16 to implement subsection (a).
- 17 (c) If a state court finds that subsection (a), or any
- 18 similar rule adopted by the board of regents, is unlawful, the
- 19 court may order, as equitable relief, that the administering
- 20 entity that is the subject of the lawsuit terminate any waiver
- 21 awarded under that statute or rule, but no money damages,
- 22 tuition refund or waiver, or other retroactive relief may be

2	application as soon as the student is able to do so.
3	For purposes of this subsection, "resident noncitizen"
4	means an individual domiciled in the State who does not have a
5	lawful immigration status.
6	(d) The board shall determine the percentage of allowable
7	tuition and fee waivers for financial need and other university
8	priorities. These tuition waivers and waivers of the
9	nonresident tuition and fee differential shall be awarded in
10	accordance with guidelines established by the board."
11	SECTION 4. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 5. This Act shall take effect upon its approval.
