A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that students who do not
- 2 hold a lawful immigration status encounter extreme hardship
- 3 attending public institutions of higher education in the State,
- 4 as they must pay a nonresident tuition and fee differential and
- 5 are not eligible for financial assistance. Many of these
- 6 students have lived in the State for the majority of their lives
- 7 and have thrived socially and academically. In addition, many
- 8 are unaware of their immigration status until they apply for
- 9 admission to institutions of higher education.
- 10 Permitting these students to access higher education with
- 11 the same benefits as resident citizens is in the public interest
- 12 as it will allow them to fully realize their potential as
- 13 productive members of society.
- 14 Under the federal Immigration and Nationality Act, states
- 15 have the authority to grant state and local public benefits to
- 16 residents who do not have lawful immigration status. The
- 17 purpose of this Act, therefore, is to increase access to higher
- 18 education by extending eligibility to participate in state



- 1 financial aid programs and exempting from the nonresident
- 2 tuition and fee differential students who meet specified
- 3 criteria.
- 4 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- 5 amended by adding a new section to be appropriately designated
- 6 and to read as follows:
- 7 "§304A- Resident noncitizens; tuition; financial aid.
- 8 (a) Students who are exempt from the nonresident tuition and
- 9 fee differential under section 304A-502(c) shall be eligible to
- 10 apply for and participate in all student financial aid and
- 11 university programs administered by the university to the full
- 12 extent permitted under federal law.
- (b) The board of regents shall adopt rules and procedures
- 14 to implement subsection (a).
- 15 (c) If a state court finds that subsection (a), or any
- 16 similar rule adopted by the board of regents, is unlawful, the
- 17 court may order, as equitable relief, that the administering
- 18 entity that is the subject of the lawsuit terminate any waiver
- 19 awarded under that statute or rule, but no money damages,
- 20 tuition refund or waiver, or other retroactive relief may be
- 21 awarded. In any action in which the court finds that subsection
- 22 (a), or any similar rule adopted by the board of regents is

- 1 <u>unlawful</u>, the university shall be immune from the imposition of
- 2 any award of money damages, tuition refund or waiver, or other
- 3 retroactive relief."
- 4 SECTION 3. Section 304A-502, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "[+]\$304A-502[+] Power of regents to grant tuition
- 7 waivers. (a) The board of regents, or its designated
- 8 representatives, is authorized to grant, modify, or suspend
- 9 tuition waivers.
- 10 (b) The board may:
- (1) Waive entirely or reduce the tuition fee or any of the
- other fees for graduate teaching and research
- assistants;
- 14 (2) Enter into agreements with government and university
- officials of any other state or foreign country to
- 16 provide for reciprocal waiver of the nonresident
- 17 tuition and fee differential;
- 18 (3) Waive the nonresident tuition and fee differential for
- 19 selected students from Pacific and Asian jurisdictions
- when their presence would be beneficial to the
- 21 university or the State;

1	(4)	Waive entirely or reduce the tuition fee or any of the
2		other fees for students, resident or nonresident; and
3	(5)	Waive the nonresident tuition and fee differential for
4		members in good standing of the following military
5		units, regardless of their actual state of residence:
6		(A) The Hawaii national guard; and
7		(B) The federal reserve components of the Army, Navy,
8		Air Force, Marine Corps, and Coast Guard who
9		attend drills with units located within the
10		State.
11	<u>(c)</u>	The board shall waive the nonresident tuition and fee
12	different	ial for any resident noncitizen student who has:
13	(1)	Attended a public or private high school in Hawaii for
14		three or more years;
15	(2)	Graduated from a public or private high school in
16		Hawaii or has attained the equivalent thereof;
17	<u>(3)</u>	Registered at or attends a campus within the
18		University of Hawaii system; and
19	(4)	Filed an affidavit with the university stating that
20		the student has filed an application to legalize the
21		student's immigration status or will file such

- 1 For purposes of this subsection, "resident noncitizen"
- 2 means an individual domiciled in the State who does not have a
- 3 lawful immigration status.
- 4 (d) The board shall determine the percentage of allowable
- 5 tuition and fee waivers for financial need and other university
- 6 priorities. These tuition waivers and waivers of the
- 7 nonresident tuition and fee differential shall be awarded in
- 8 accordance with guidelines established by the board."
- 9 SECTION 4. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 5. This Act shall take effect upon its approval.
