### A BILL FOR AN ACT

RELATING TO THE FEDERAL VIOLENCE AGAINST WOMEN ACT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that one of the goals of
- 2 the federal Violence Against Women Act, Pub. L. 106-386, 114
- 3 Stat. 1491, is to protect women who are victims of domestic
- 4 violence or sexual assault, including undocumented immigrants,
- 5 from their perpetrators.
- 6 The United States Department of Justice, through the Office
- 7 on Violence Against Women, encourages nonprofits, community-
- 8 based organizations, and other social services to aid victims of
- 9 violence by providing legal and social services to enable women
- 10 to report abuse and cooperate with law enforcement without fear
- 11 of being legally reprimanded due to their immigration status.
- 12 The Violence Against Women Act created special rules for
- 13 undocumented immigrants who are victims of domestic violence or
- 14 sexual assault to allow them to apply for a work permit and a U-
- 15 visa, which provides immigration status to noncitizens willing
- 16 to assist authorities in investigating crimes.
- 17 However, despite the Violence Against Women Act, many
- 18 domestic violence or sexual assault victims do not report

- 1 perpetrators or help to prosecute them because of fear of
- 2 deportation. Also, many victims are unfamiliar with the laws
- 3 that protect them and their children. Additionally, women who
- 4 have cooperated with authorities have been unable to financially
- 5 support their families because of a lack of job experience, job
- 6 training, and interviewing skills.
- 7 The purpose of this Act is to request that the department
- 8 of human services establish a pilot project to enable community-
- 9 based organizations to provide legal advice and social services
- 10 to victims of domestic violence or sexual assault who are
- 11 undocumented immigrants, in accordance with the goals of the
- 12 federal Violence Against Women Act.
- 13 SECTION 2. (a) The department of human services may
- 14 establish a pilot program to assist undocumented immigrants who
- 15 are victims of domestic violence or sexual assault, including
- 16 assistance qualifying for protection under the federal Violence
- 17 Against Women Act.
- 18 (b) If established, the pilot project shall provide the
- 19 following services to undocumented immigrants who are victims of
- 20 domestic violence or sexual assault:
- 21 (1) Assistance with restraining orders;

2		federal Violence Against Women Act, U-visas, and work
3		permits;
4	(3)	Workshops on building self-esteem and self-confidence;
5	(4)	Instruction on appropriate workplace etiquette and
6		appearance;
7	(5)	Training in effective job search techniques;
8	(6)	Career assessments, when appropriate, to identify
9		marketable skills and assess employability;
10	(7)	Information about current labor market trends for
11		employment and training;
12	(8)	Placement with employers who agree to hire a
13		prearranged number of victims;
14	(9)	Post-employment services;
15	(10)	Legal assistance with divorces, child custody and
16		support, housing and consumer issues, and other family
17		law issues; and
18	(11)	Case management needs, including language learning and
19		information and assistance using public
20		transportation, obtaining identification, and other
21		skills as necessary.

- 1 (c) If the pilot program is established, the department of
- 2 human services shall submit a report to the legislature no later
- 3 than twenty days prior to the convening of the regular session
- 4 of 2014, including the number of victims who received services
- 5 and the types of assistance they received.
- 6 SECTION 3. This Act shall take effect upon its approval
- 7 and shall be repealed on June 30, 2014.
