A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII: 1 SECTION 1. The importance of agriculture to the State is 2 reflected in the Hawaii State Constitution, Article XI, section 3 Agriculture not only provides food and other basic needs 4 to society, but has also proven to be an economic engine 5 supporting the State. Agriculture provides the basis for 6 increased self sufficiency, which is important to an island 7 state. 8 Increased globalization and changes in food management have 9 introduced new risks in the food supply system. Risks occur at 10 all levels of food production and management, and are not 11 inherent to any one type of operation. The 2011 Colorado 12 cantaloupe foodborne illness incident demonstrated that 13 individual incidents are far reaching, impacting the entire 14 industry and related industries within the locale. New risks 15 constantly arise, such as the emergence of the rat lungworm

- 1 foodborne illnesses illustrate the need to understand the
- 2 innumerable details involved in food production and to implement
- 3 practices that result in food safety.
- 4 The agricultural industry has recognized that there are
- 5 practices that if done correctly, can result in good stewardship
- 6 of the land, increased worker safety, and ultimately lead to
- 7 safe products for the consumer. These practices, known as
- 8 generally accepted agricultural and management practices are
- 9 written to provide uniform, statewide standards and acceptable
- 10 management practices based on science. These practices can
- 11 assist producers in the various sectors of the industry in
- 12 improving their own agricultural managerial routines. The
- 13 generally accepted agricultural and management practices are
- 14 reviewed annually and revised as new scientific discoveries and
- 15 changing economic conditions require. Generally accepted
- 16 agricultural and management practices are recognized by
- 17 regulatory agencies such as the United States Food and Drug
- 18 Administration.
- 19 Livestock generally accepted agricultural and management
- 20 practices provide quidance for ranchers to ensure sound animal
- 21 welfare practices and promote animal husbandry and care. State
- 22 adoption and recognition of these standards are critical to

- 1 allow farmers and ranchers to have access to the widest array of
- 2 tools to provide agricultural products to the people of Hawaii.
- 3 The purpose of this Act is to strengthen the agricultural
- 4 safety and security program of the department of agriculture.
- 5 SECTION 2. Chapter 147, Hawaii Revised Statutes, is
- 6 amended by adding a new section to part VIII to be appropriately
- 7 designated and to read as follows:
- 8 "\$147-A Agricultural practices audit and certification
- 9 revolving fund. (a) There is established the agricultural
- 10 practices audit and certification revolving fund under the
- 11 department.
- 12 (b) Fees received by the department for audits and
- 13 certifications under this part shall be deposited into the
- 14 revolving fund.
- 15 (c) The proceeds of the revolving fund shall be expended

- 1 The department shall adopt the generally accepted 2 agricultural and management practices without necessity of 3 compliance with chapter 91; provided that the department shall 4 hold at least one public hearing in each county before adopting 5 or materially revising the general accepted agricultural and 6 management practices. The determination of whether a proposal 7 requires a public hearing shall rest exclusively with the 8 department. 9 (c) Participation in the program of this part shall be voluntary for producers. The department shall conduct audit and **10** 11 certification services under the program only for producers who apply and pay the relevant fee to and comply with other **12** 13 requirements set by the department. 14 As part of the program, the department shall assist, train, 15 and educate producers in complying with the applicable generally **16** accepted agricultural and management practices. 17 The department shall not require any producer to be subject 18 to audit or certification if the producer has not applied to 19 participate in the program." 20 SECTION 8. Report Title:

Agriculture; Agricultural Safety and Security program

Description:

Requires the department of agriculture to establish an agricultural safety and security program. Requires, under the program, the department to conduct audit and certification services that indicate a producer's compliance with generally accepted agricultural and management practices and food security and traceability requirements. Specifies that the program is voluntary for producers. Requires the charge of fees and expenses. Establishes an agricultural practices audit and certification revolving fund for the program.
