
A BILL FOR AN ACT

MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE
LEGISLATURE, THE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU,
THE OMBUDSMAN, AND THE ETHICS COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$7,377,244 or so much
3 thereof as may be necessary to the senate for the following
4 expenses:

5 (1) The sum of \$6,477,244 for defraying any and all
6 session and nonsession expenses of the senate up to
7 and including June 30, 2013, including the 2012
8 regular session, twenty-sixth legislature of the State
9 of Hawaii, and pre-session expenses and the expenses
10 of any committee or committees established during the
11 interim between the 2012 and 2013 regular sessions;
12 and

13 (2) The sum of \$900,000 for defraying the expenses of the
14 legislative information system for cost items such as
15 hardware, software, consultants, installation,
16 materials, supplies, and other related costs



1 associated with the legislative information system
2 that have been or will be incurred.

3 The sum appropriated in this section shall be expended by
4 the senate.

5 SECTION 2. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$10,481,787 or so
7 much thereof as may be necessary to the house of representatives
8 for the following expenses:

9 (1) The sum of \$9,793,363 for defraying any and all
10 session and nonsession expenses of the house of
11 representatives up to and including June 30, 2013,
12 including the 2012 regular session, twenty-sixth
13 legislature of the State of Hawaii, and pre-session
14 expenses and the expenses of any committee or
15 committees established during the interim between the
16 2012 and 2013 regular sessions; and

17 (2) The sum of \$688,424 for defraying the expenses of the
18 legislative information system for cost items such as
19 hardware, software, consultants, installation,
20 materials, supplies, and other related costs
21 associated with the legislative information system
22 that have been or will be incurred.



1 The sum appropriated in this section shall be expended by
2 the house of representatives.

3 SECTION 3. Payment of expenses of the senate during the
4 interim between the 2012 and 2013 regular sessions shall be made
5 only with the approval of the president of the senate, and
6 payment of expenses of the house of representatives during the
7 interim between the 2012 and 2013 regular sessions shall be made
8 only with the approval of the speaker of the house of
9 representatives.

10 SECTION 4. Before January 16, 2013, the senate and the
11 house of representatives shall each have their accounts audited,
12 and a full report of the respective audits shall be presented to
13 the senate and to the house of representatives convening on
14 January 16, 2013.

15 SECTION 5. Unless otherwise prescribed by law, the
16 expenses of any member of the legislature while traveling abroad
17 on official business of the legislature shall be \$145 a day as
18 authorized by the president of the senate and the speaker of the
19 house of representatives.

20 SECTION 6. There is appropriated out of the general
21 revenues of the State of Hawaii the sum of \$2,663,849 or so much



1 thereof as may be necessary to the office of the auditor for the
2 following expenses:

3 (1) The sum of \$2,513,849 for defraying the expenses of
4 the office of the auditor during fiscal year
5 2012-2013; and

6 (2) The sum of \$150,000 during fiscal year 2012-2013 for:

7 (A) Performing special studies;

8 (B) Improving capabilities for planning, programming,
9 and budgeting;

10 (C) Fulfilling other special requests made of the
11 auditor by the legislature or jointly by the
12 president of the senate and the speaker of the
13 house of representatives;

14 (D) Legislative studies and contractual services for
15 those studies; and

16 (E) Such other purposes as may be determined by the
17 joint action of the president of the senate and
18 the speaker of the house of representatives.

19 The sum appropriated in this section shall be expended by
20 the auditor.



1 SECTION 7. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$2,550,828 or so much
3 thereof as may be necessary to the office of the auditor during
4 fiscal year 2012-2013 to be deposited into the audit revolving
5 fund established pursuant to section 23-3.6, Hawaii Revised
6 Statutes.

7 SECTION 8. There is appropriated out of the audit
8 revolving fund the sum of \$6,000,000 or so much thereof as may
9 be necessary to the office of the auditor during fiscal year
10 2012-2013 for the office to conduct or complete its audit
11 functions as provided by law.

12 The sum appropriated in this section shall be expended by
13 the auditor.

14 SECTION 9. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$3,033,970 or so much
16 thereof as may be necessary to the legislative reference bureau
17 for defraying the expenses of the legislative reference bureau
18 during fiscal year 2012-2013, including equipment relating to
19 computer systems programming and operations.

20 The sum appropriated in this section shall be expended by
21 the legislative reference bureau.



1 SECTION 10. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$1,017,875 or so much
3 thereof as may be necessary to the office of the ombudsman for
4 defraying the expenses of the office during fiscal year
5 2012-2013.

6 The sum appropriated in this section shall be expended by
7 the ombudsman.

8 SECTION 11. There is appropriated out of the general
9 revenues of the State of Hawaii the sum of \$849,531 or so much
10 thereof as may be necessary to the office of the state ethics
11 commission for defraying the expenses of the office during
12 fiscal year 2012-2013.

13 The sum appropriated in this section shall be expended by
14 the state ethics commission.

15 SECTION 12. There is appropriated out of the general
16 revenues of the State of Hawaii the following sums or so much
17 thereof as may be necessary for defraying the cost of the
18 legislative broadcasting program:

19 (1) \$87,500 to the senate; and

20 (2) \$87,500 to the house of representatives.



1 This appropriation shall be used to pay for the production and
2 distribution of television broadcasts of legislative
3 proceedings.

4 SECTION 13. Except for moneys in the audit revolving fund,
5 as of the close of business on June 30, 2013, the unexpended or
6 unencumbered balance of any appropriation made by this Act shall
7 lapse into the general fund.

8 SECTION 14. Each section of this Act is declared to be
9 severable from the remainder of this Act.

10 SECTION 15. This Act shall take effect upon its approval.
