A BILL FOR AN ACT

RELATING TO SOLAR ENERGY DEVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 196-7, Hawaii Revised Statutes, is
- 2 amended by amending subsection (b) to read as follows:
- 3 "(b) Every private entity shall adopt rules by
- 4 December 31, 2006, that provide for the placement of solar
- 5 energy devices, and revise those rules as necessary by July 1,
- 6 2011. The rules shall facilitate the placement of solar energy
- 7 devices and shall not impose conditions or restrictions that
- 8 render the device more than twenty-five per cent less efficient
- 9 or increase the cost of installation, maintenance, and removal
- 10 of the device by more than fifteen per cent. Notwithstanding
- 11 these conditions or restrictions, the rules shall consider the
- 12 impact of the device's reflectivity on the surrounding area
- 13 within feet of the device. No private entity shall assess or
- 14 charge any homeowner any fees or require an encumbrance on title
- 15 for the placement of any solar energy device."
- 16 SECTION 2. Section 196-7, Hawaii Revised Statutes, is
- 17 amended by amending subsection (b) to read as follows:

- 4 The rules shall facilitate the placement of solar energy devices

- 6 device more than twenty-five per cent less efficient or increase
- 7 the cost of installation, maintenance, and removal of the device
- 8 by more than fifteen per cent. Notwithstanding these conditions
- 9 or restrictions, the rules shall consider the impact of the
- 10 device's reflectivity on the surrounding area within feet of
- 11 the device. No private entity shall assess or charge any
- 12 homeowner any fees [or require an encumbrance on title] for the
- 13 placement of any solar energy device."
- 14 SECTION 3. Act 201, Session Laws of Hawaii 2010, is
- 15 repealed.
- 16 SECTION 4. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 5. This Act, except section 2, shall take effect
- 19 on July 1, 2012; provided that on June 30, 2015:

- 1 (1) Section 1 of this Act shall be repealed; and
- 2 (2) Section 2 of this Act shall take effect.
