A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

"Autism spectrum disorders" means any of the following 3 disorders as defined in the most recent edition of the 4 Diagnostic and Statistical Manual of Mental Disorders of the 5 6 American Psychiatric Association: 7 (1) Autistic disorder; 8 (2) Asperger's syndrome; (3) Childhood disintegrative disorder; 9 (4) Rett syndrome; and 10 Pervasive developmental disorder not otherwise 11 (5) specified. 12 "Diagnosis" means medically necessary assessments, 13 evaluations, or tests to diagnose whether an individual has an 14 autism spectrum disorder. 15 "Medically necessary" means any care, treatment, 16 intervention, service, or item that is prescribed, provided, or 17 ordered by a licensed physician, licensed psychologist, or 18 certified registered nurse practitioner in accordance with 19
