RELATING TO BUSINESS ENTITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 428-101, Hawaii Revised Statutes, is
2	amended by adding a new definition to be appropriately inserted

4	"Low-profit limited liability company" means a person
5	organized under this chapter that is organized for a business
6	purpose that satisfies and is at all times operated to satisfy
7	each of the following requirements:
8	(1) The company:
9	(A) Significantly furthers the accomplishment of one
10	or more charitable or educational purposes within
11	the meaning of section 170(c)(2)(B) of the
12	Internal Revenue Code of 1986, as amended; and
13	(B) Would not have been formed but for the company's
14	relationship to the accomplishment of charitable
15	or educational purposes;
16	(2) No significant purpose of the company shall be the
17	production of income or the appreciation of property;
18	provided, however, that the fact that a person

2		shall not, in the absence of other factors, be		
3		conclusive evidence of a significant purpose involving

11		definition at its formation at any time ceases to
