### A BILL FOR AN ACT

RELATING TO RE-OPENING THE KULANI CORRECTIONAL FACILITY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Kulani correctional facility closed on
- 2 November 20, 2009, and the facility was transferred to the state
- 3 department of defense. The incarcerated population of
- 4 approximately one hundred twenty at the Kulani correctional
- 5 facility was transferred to the Halawa correctional facility, to
- 6 the federal detention center in Honolulu, and to mainland
- 7 prisons. The Kulani correctional facility specialized in
- 8 providing sex offender treatment, which the department of public
- 9 safety describes as being one of the most successful programs in
- 10 the country.
- 11 The legislature finds that Hawaii's incarcerated persons
- 12 who serve their incarceration sentence in Hawaii have more
- 13 potential for rehabilitation when they can live in familiar
- 14 surroundings and be close to relatives. In addition, the sex
- 15 offender treatment services that were provided at the Kulani
- 16 correctional facility were among the finest in the country.
- 17 Consideration of the costs of incarceration on the mainland,
- 18 rather than incarceration in Hawaii, is outweighed by the

- 1 rehabilitation success of persons incarcerated in Hawaii.
- 2 Successful rehabilitation eventually results in lower recidivism
- 3 and lower costs.
- 4 The Kulani correctional facility has since been converted
- 5 to a second site for the Hawaii National Guard Youth Challenge
- 6 Academy. The Youth Challenge Academy and other stakeholders
- 7 have since located a site at the Keaukaha Military Reservation
- 8 that may be a suitable replacement site. However, the new
- 9 proposed site does not have an appropriate facility to house
- 10 cadets.
- 11 The purpose of this Act is to require the department of
- 12 public safety to make plans to reopen the Kulani correctional
- 13 facility and to appropriate funds for plans and design of new
- 14 barracks for the Youth Challenge Academy at the Keaukaha
- 15 Military Reservation.
- 16 SECTION 2. (a) No later than December 31, 2012, the
- 17 department of public safety shall develop a plan to reopen the
- 18 Kulani correctional facility, including an implementation
- 19 process to transfer back incarcerated persons to and house new
- 20 inmates at the Kulani correctional facility.

- 1 (b) The emphasis of the reopened Kulani correctional
- 2 facility shall be on providing sex offender treatment
- 3 rehabilitation services.
- 4 (c) The state department of defense shall cooperate with
- 5 the department of public safety to transfer the Kulani
- 6 correctional facility back to the department of public safety.
- 7 (d) The department of public safety is urged to assist the
- 8 state department of defense in identifying alternative sites for
- 9 the Kulani Youth Challenge Academy.
- 10 (e) The department of public safety, when staffing the
- 11 Kulani correctional facility upon its reopening, shall first
- 12 offer positions to former Kulani employees in the positions they
- 13 held prior to the closing of the facility and, with the
- 14 exception of those who wish to remain in a different location,
- 15 offer positions to any and all employees who may have been
- 16 bumped, terminated, or accepted employment in a new geographical
- 17 location regardless of any agreements made between the employee
- 18 and the employer regarding transferring back to their original
- 19 workplace. Positions shall be offered first to former employees
- 20 of Kulani and Hawaii Community Correctional Center before
- 21 allowing any other transfers from employees who were not

- 1 affected or employed by Kulani or Hawaii Community Correctional
- 2 Center at the time of the closing.
- 3 (f) The department of public safety shall submit its plan
- 4 and any related findings and recommendations to the legislature
- 5 no later than twenty days prior to the convening of the regular
- 6 session of 2013.
- 7 SECTION 3. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$300,000 or so much
- 9 thereof as may be necessary for fiscal year 2012-2013 for plans
- 10 and design to build a housing facility for the Youth Challenge
- 11 Academy on the Keaukaha Military Reservation site.
- 12 The sum appropriated shall be expended by the department of
- 13 defense for the purposes of this Act.

14 SECTION 4. This Act shall take effect on July 1, 2012.
