- 7 vacancy to the remaining members of the council after making the

- 14 SECTION 3. This Act shall take effect upon its approval;
- 15 provided that this Act shall be repealed on June 30, 2014, and

- 17 the form in which it read on the day before the effective date
- 18 of this Act.
