## A BILL FOR AN ACT

RELATING TO AGRICULTURE INSPECTORS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that support for the
2	biosecurity program under the department of agriculture is
3	important because of the impact of invasive species to Hawaii's
4	agriculture, environment, natural resources, public health, and
5	economy. The legislature also finds that the United States
6	Department of Agriculture and other states' departments of
7	agriculture also face shortages in agriculture inspectors.
8	Therefore, to improve the effectiveness of the biosecurity
9	program, the legislature finds that providing the state
10	department of agriculture with the authority to establish,
11	maintain, and enforce compliance agreements with federal or
12	other state departments of agriculture will allow the federal
13	and other state departments of agriculture and their respective
14	inspectors to work cooperatively with Hawaii's agriculture
15	inspectors on import and export programs.
16	The importation of christmas trees is considered a high

risk for invasive species introduction into the State. This

measure would allow the Hawaii department of agriculture to

- 1 enter into compliance agreements with the Oregon department of
- 2 agriculture and Washington department of agriculture to monitor
- 3 the growing and packing of christmas trees to reduce the amount
- 4 of invasive species that may hitchhike with shipments to Hawaii.
- 5 For export, our fruits industry, valued at \$30,000,000;
- 6 vegetable industry, valued at \$75,000,000; and floral and
- 7 nursery industry, valued at \$100,000,000 are at risk of losing
- 8 export markets due to quarantine measures imposed by the federal
- 9 government and other states. To assist the agricultural
- 10 industry, the legislature recommends that the Hawaii department
- 11 of agriculture enter into compliance agreements with receiving
- 12 states to establish origin-inspection programs to ease
- 13 quarantine restrictions placed on Hawaii's growers.
- 14 The purpose of this Act is to provide the department of
- 15 agriculture with authority to establish, maintain, and enforce
- 16 compliance agreements with federal or state departments of
- 17 agriculture as to the import and export of plant commodities,
- 18 and to assess fees for conducting inspections required under
- 19 compliance agreements.
- 20 SECTION 2. Section 141-2, Hawaii Revised Statutes, is
- 21 amended to read as follows:

1 "\$141-2 Rules. Subject to chapter 91, the department of

2 agriculture shall adopt, amend, and repeal rules not

3 inconsistent with law, for and concerning:

- 4 (1) The introduction, transportation, and propagation of trees, shrubs, herbs, and other plants;
- The quarantine, inspection, fumigation, disinfection, (2) 6 destruction, or exclusion, either upon introduction 7 8 into the State, or at any time or place within the 9 State, of any nursery-stock, tree, shrub, herb, vine, 10 cut-flower, cutting, graft, scion, bud, seed, leaf, root, or rhizome; any nut, fruit, or vegetable; any 11 12 grain, cereal, or legume in the natural or raw state; 13 any moss, hay, straw, dry-grass, or other forage; any 14 unmanufactured log, limb, or timber; or any other 15 plant growth or plant product unprocessed or in the raw state; any sand, soil, or earth; any live bird, 16 17 reptile, insect, or other animal, in any stage of development, that is in addition to the so-called 18 19 domestic animals, which are provided for in section 20 142-2; and any box, barrel, crate, or other containers 21 in which the articles, substances, or objects have 22 been transported or contained, and any packing

1		material used in connection therewith, that is or may
2		be diseased or infested with insects or likely to
3		assist in the transmission or dissemination of any
4		insect or plant disease injurious, harmful, or
5		detrimental, or likely to become injurious, harmful,
6		or detrimental to the agricultural or horticultural
7		industries or the forests of the State, or that is or
8		may be in itself injurious, harmful, or detrimental to
9		the same [+]; provided that included therein may be
10		rules governing the transportation of any of the
11		articles, substances, or objects enumerated above in
12		this section between different localities on any one
13		of the islands within the State[+];
14	(3)	The prohibition of importation into the State, from
15		any or all foreign countries or from other parts of
16		the United States, or the shipment from one island
17		within the State to another island therein, or the
18		transportation from one part or locality of any island
19		to another part or locality of the same island, of any
20		specific article, substance, or object or class of
21		articles, substances, or objects, among those
22		enumerated above in this section, that is diseased or

1	ŧ	infested with insects or likely to assist in the
2		transmission or dissemination of any insect or plant
3		disease injurious, harmful, or detrimental or likely
4		to be injurious, harmful, or detrimental to the
5		agricultural or horticultural industries, or the
6		forests of the State, or that is or may be in itself
7		injurious, harmful, or detrimental to the same;
8	(4)	The preparation by cargo carriers of manifests of
9		cargo transported into the State or between islands of
10		the State and the submission of the manifests to the
11		department; [and]
12	(5)	The establishment, maintenance, and enforcement of
13		compliance agreements with federal or state
14		departments of agriculture authorizing agriculture
15		inspectors from the state of origin in the case of
16		imports to the State, or State agricultural inspectors
17		in the case of State exports, to monitor the growing
18		and packing of plant commodities and any treatment
19		procedures to insure compliance with quarantine laws,
20		and further authorizing the assessment of fees for
21		conducting inspections required under the compliance
