## A BILL FOR AN ACT

RELATING TO CHAPTER 328J, HAWAII REVISED STATUTES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 328J, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§328J- Establishments at which smoking is permitted.
5	(a) Every establishment identified in section 328J-3(b) shall
6	comply with the requirements of section 328J-3(c) prior to
7	permitting smoking within its premises.
8	(b) The department shall adopt rules under chapter 91 to
9	effectuate this section."
10	SECTION 2. Section 328J-3, Hawaii Revised Statutes, is
11	amended to read as follows:
12	[[+]§328J-3[+] Prohibition in enclosed or partially
13	enclosed places open to the public. (a) Smoking shall be
14	prohibited in all enclosed or partially enclosed areas open to
15	the public, including but not limited to the following places:
16	(1) Airports and public transportation facilities and
17	vehicles, including buses and taxicabs, under the

authority of the State or county, and ticket,

2		including airports from curb to cabin and including
3		all areas within and immediately in front of and

8	(3)	Areas available to and customarily used by the general
9		public, including but not limited to restrooms,

11		areas, in businesses and nonprofit entities patronized
12		by the public, including but not limited to
13		professional offices, banks, laundromats, hotels, and
14		motels;
15	(4)	Bars;
16	(5)	Bowling alleys;

20	exempt from	om the provisions of sections 328J-3, 328J-4, and
21	328J-5:	

1	( 1 )	Private residences, except when used as a licensed
2		child care, adult day care, or health care facility;
3	(2)	Hotel and motel rooms that are rented to guests and
4		are designated as smoking rooms; provided that not
5		more than twenty per cent of rooms rented to guests in
6		a hotel or motel may be so designated. All smoking
7		rooms on the same floor shall be contiguous and smoke
8		from these rooms shall not infiltrate into areas where
9		smoking is prohibited under this chapter. The status
10		of rooms as smoking or nonsmoking may not be changed,
11		except to add additional nonsmoking rooms;
12	(3)	Retail tobacco stores; provided that smoke from these
13		places shall not infiltrate into areas where smoking
14		is prohibited under this chapter;
15	(4)	Private and semiprivate rooms in nursing homes and
16		long-term care facilities that are occupied by one or
17		more persons, all of whom are smokers and have
18		requested in writing to be placed in a room where
19		smoking is permitted; provided that smoke from these
20		places shall not infiltrate into areas where smoking

is prohibited under this chapter;

5		of a production being filmed; [and]
6	(7)	State correctional facilities; provided that smoking

8		of a correctional facility in an area outside the
9		secure confines of a correctional facility restricted
10		from access by inmates or detainees that has been
11		designated by the warden of a correctional
12		facility[+]; and
13	(8)	The premises of establishments identified in section
14		328J-3(b) that comply with section 328J-3(c)."

- 4 SECTION 5. Section 328J-9, Hawaii Revised Statutes, is
- 5 amended to read as follows:
- 6 "[+]\$328J-9[+] Signs. (a) Clearly legible signs that
- 7 include the words "Smoking Prohibited by Law" with letters of
- 8 not less than one inch in height or the international "No
- 9 Smoking" symbol, consisting of a pictorial representation of a
- 10 burning cigarette enclosed in a red circle with a red bar across
- 11 it, shall be clearly and conspicuously posted in and at the
- 12 entrance to every place open to the public and place of
- 13 employment where smoking is prohibited by this chapter by the
- 14 owner, operator, manager, or other person in control of that
- 15 place.
- 16 (b) Clearly legible signs that include the words "Smoking
- 17 Permitted" with letters of not less than one inch in height or
- 18 the international "Smoking Permitted" symbol, consisting of a
- 19 pictorial representation of a burning cigarette enclosed in a
- 20 green circle, shall be clearly and conspicuously posted at the
- 21 entrance to and inside every establishment identified in section
- **22** 328J-3(b)."

Smoking; Bars; Nightclubs; Liquor license

## Description:

Permits bars and nightclubs with dispenser licenses in counties with a population of at least 700,000 to allow smoking by posting "smoking permitted" signs and provides that no county ordinance shall prohibit or restrict smoking in these establishments. Effective January 1, 2112. (HB2306 HD1)
