A BILL FOR AN ACT

RELATING TO MOPEDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 291C-195, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§291C-195 Driving of mopeds. (a) No person less than
- 4 fifteen years of age shall drive a moped on a highway, street,
- 5 roadway, or any other public property in the State. No person
- 6 less than eighteen years of age shall drive a moped unless the
- 7 person wears a safety helmet securely fastened with a chin
- 8 strap. The safety helmet shall meet the specifications and
- 9 requirements established by rules adopted by the director.
- 10 (b) No person shall drive a moped except while sitting
- 11 astride the seat, facing forward, with one leg on each side of
- 12 the moped.
- 13 (c) No person shall drive a moped which is carrying any
- 14 other person nor shall any person other than the driver ride
- 15 upon a moped.
- (d) No person shall drive a moped while carrying any
- 17 package, bundle, or other article which prevents the person from
- 18 keeping both hands on the handlebars.

- 10 SECTION 2. Section 291C-196, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- 12 "§291C-196 Driving mopeds on roadways. (a) Every person
- 13 driving a moped, except a three-wheeled moped, upon a roadway at
- 14 a speed less than the normal speed of traffic moving in the same
- 15 direction at such time shall ride as near to the right side of
- 16 the roadway as practicable, exercising due care when passing a
- 17 standing vehicle or one proceeding in the same direction, except
- 18 under any of the following situations:
- 19 (1) When preparing for a left turn at an intersection or
- into a private road or driveway, except where
- 21 prohibited by official traffic-control devices;

1	(2)	When reasonably necessary to avoid conditions
2		[+]including, but not limited to fixed or moving
3		objects, vehicles, bicycles, pedestrians, animals,

- 7 (3) When a roadway is designated and signposted to carry
 8 traffic in one direction only and has two or more
 9 marked traffic lanes, a person operating a moped may
 10 ride as near to the left-hand side of the roadway as
 11 practicable.
- (b) Persons driving mopeds upon a roadway shall drive insingle file.
- 14 (c) No person shall drive a moped on any sidewalk or area 15 intended for use as a sidewalk, nor shall any person drive a 16 moped on any path or other area intended for the exclusive use 17 of pedestrians.
- (d) A three-wheeled moped shall be restricted to traveling on roadways with a posted speed limit of thirty-five miles per hour or less.
- (e) The driver of a moped shall not overtake and pass inthe same lane occupied by the vehicle being overtaken.

- 1 (f) No person shall drive a moped between lanes of traffic
- 2 or between adjacent lines or rows of vehicles."
- 3 SECTION 3. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 4. This Act shall take effect upon its approval.

Report Title:

Mopeds; Statewide Traffic Code

Description:

Prohibits persons driving a moped from carrying any package, bundle, or other article which prevents the person from keeping both hands on the handlebars. Prohibits the operation of a moped with handlebars more than fifteen inches in height above that portion of the seat occupied by the driver. Prohibits the driver of a moped from overtaking and passing in the same lane occupied by the vehicle being overtaken. Prohibits the operation of a moped between lanes of traffic or between adjacent lines or rows of vehicles.
